


Whitaker Field Education Conference

In celebration of its 30th Anniversary, the School of Social Work hosted a two day conference in October 2006. Its title "Unfolding the Elsewhere and Otherwise" encouraged us to think critically, as Dr. Lena Dominelli explained, what it means to be "riding the justice train" and what we do to make this iourney of eradicating social inequalities possible. It was a truly successful event that generated rich, critical, and thought provoking discussions on the educational and practice possibilities of social justice in social work. The event brought together field educators, students, researchers, field supervisors and interested community members for a number of

presentations and workshops. Social Work 391 titled "Indigenous Approaches to Healing and Helping" earned the award for its interactive and creative approach of delivering the curriculum.

The distance education course is offered electronically and encompasses web-based group discussion, audio files, video/DVD materials, and a course manual. It is designed with the objective of enabling Indigenous students to directly interact with First Nations elders, political leaders and human service workers.

In addition, students explore the traditional and contemporary approaches used by Indigenous peoples to effect positive changes and engage in healing within their communities.

The DVD series titled "Indigenous Renewal: Time for Life Again" is used in the curriculum for the course. It was produced by Lifting Children's Spirit Society, a grassroots non-profit society located in the traditional territory of Chemainus people of the Coast Salish Nation. The DVD features Lennie Louie, Corie Moran-Adakai, Frank Adakai, and Sean Brown.







An Opportunity to Enhance Supervisory Skills

Web-based Interactive Supervisor's Course

This free, ten to twelve week online course for UVIC social work practicum supervisors, or perspective supervisors, offers a unique opportunity to:

- > explore the recent literature on practice supervision
- > consider the links between social work theory and practice and,
- > share supervisory experiences and ideas with other practitioners.

This fun, innovative course provides concrete tools for supervision both with students and others in the workplace. The intent of the course is to mirror the characteristics of a dynamic learning environment for the practicum student.

The course is divided into core and optional modules which are delivered in a user friendly online environment. Student voices and experiences are included in the course through the use of audio vignettes. Participants who successfully complete four modules will receive a certificate from the School of Social Work. Count on setting aside five hours per week for participation.

The first of offering of the course wrapped up in December, 2006, with 11 graduates receiving certificates.

Indigenous MSW Program




The School of Social Work is excited to announce that an Indigenous MSW program is currently seeking approval from the University of Victoria Faculty of Graduate Studies. Notification of when the program is open for admissions will be given in the near future.

During the program development, a pilot form of the program was being hosted in the Cowichan area and made up of workers from First Nations child and family serving agencies. Students began taking course work in January 2005. They are in their second academic year of the pilot program and are now in the midst of completing the thesis or research project degree requirements.

Along with fulfilling all the requirements of a regular MSW degree program, the FNMSW program is designed with a specialized focus on areas such as developing and reinforcing skills and knowledge that contribute to First Nations communities and improve policies and practices at First Nations service agencies.
