Course objective: The aim of the course is to examine and discuss philosophical issues concerning religious experience and belief. Topics include the nature of religious experience, religious diversity, politics, and public life, the nature and plausibility of arguments for and against theism, and the distinction between faith and reason. The goal is to develop a solid understanding of the key areas in philosophy of religion, and to engage critically with key textual sources in the field.

Lectures are designed to make the reading material **accessible and understandable** to students.

Lectures and class attendance: Note that lectures will almost always introduce concepts and figures that are not mentioned in class readings. Examination and test questions are based on lecture content. Lectures will be mixed with in-class writing activities. Well-maintained notes will provide an invaluable support to your successful completion of the tests, in class exercises, and final exam.

•Paraphrases material from a source without sufficient acknowledgment as described above The university reserves the right to use plagiarism detection software programs to detect plagiarism in essays, term papers and other work.

Cheating on Tests and Examinations: Any instance of impersonation of a student during an exam should result in a grade of F for the course for the student being impersonated, and disciplinary probation for the impersonator (if he or she is a student). Isolated instances of copying the work of another student during an exam should result in a grade of zero for the exam. Systematic copying of the work of another student (or any other person with access to the exam questions) should result in a grade of F for the course. Any instance of bringing unauthorized equipment or material into an exam should result in a grade of zero for the exam. Sharing information or answers for take-home assignments and tests when this is clearly prohibited in written instructions should result in a grade of F for the course when such sharing covers a substantial part of the work.
