#### **OBJECTIVES**

To familiarize students with the concept of intellectual property and with the principles and policies of selected areas of intellectual property.

## **COURSE DESCRIPTION**

A study of the concepts, principles, and policies of intellectual property law, the relationship and boundary issues between types of intellectual property as well as broader dimensions of cultural creativity. The primary focus is on a) copyright and "literary," "musical," and "artistic" works, technological applications, economic and moral rights, infringement and fair dealing or user interests; and b) registered trademarks and related common law provisions.

## **METHODOLOGY**

## **EXPECTED EVALUATION METHODOLOGY**

- 1. Optional mid-term written examination to count 40% of the final mark if it increases that mark.
- 2. Final written examination.
