COURSE DESCRIPTION

This course is about civil procedure in the Supreme Court of British Columbia. Civil procedure is much more than a set of rules. It is the toolkit and tradecraft of an effective litigator. In this course, students will learn to think practically and creatively about how the rules of civil procedure can be used to achieve results for clients in a strategic, ethical, and cost-effective manner. Students will also learn how to draft the most important types of court documents.

COURSE OBJECTIVE

Students will gain a strong foundation in the practical knowledge and skills that are needed in civil litigation, including:

- a) the foundational principles of civil procedure;
- b) practical and strategic considerations arising from the economics of litigation;
- c) the main procedural steps in an action;
- d) how to bring and respond to a chambers application;
- e) options for obtaining relief on a summary basis without a full trial;
- f) petition proceedings and when to use them;
- g) how to draft a notice of civil claim, response to civil claim, notice of application, and affidavit; and,
- h) the main professional obligations that arise in connection with procedural issues.

TEACHING METHODOLOGY

Class participation is strongly encouraged. Most classes will include an exercise of some kind, to be completed in small groups. We will prepare and distribute a casebook; no textbook will need to be purchased. The reading will not be onerous, although there will be several assignments (detailed below).

EXPECTED EVALUATION METHODOLOGY

- Class participation (5%)
- Assignment #1: drafting a notice of civil claim (10%)
- Assignment #2: drafting a response to civil claim (10%)
- Assignment #3: drafting a notice of application and affidavit (20%)
- Oral advocacy exercise (5%)
- Final exam (take home and open book) (50%)

ABOUT THE INSTRUCTORS

Lee Mauro is a lawyer in the Litigation Group of the Ministry of Attorney General of British Columbia, practicing civil litigation and administrative law with a focus on class proceedings. Prior to joining the Ministry of Attorney General in 2019, Lee articled and practiced at Harper Grey LLP, then practiced at leading boutique firms in Vancouver and Victoria. Lee has always maintained a practice that was diverse in subject matter but focused exclusively on litigation.
