# Director's Message

In 2010/11 CAPI's usual round of outstanding events was mounted alongside our quinquennial review process. Despite being overstretched CAPi welcomed the opportunity to take a look at itself with the benefit of expert advice and ideas from within and beyond UVic, and was happy with the outcome of the review process, which both confirmed our great performance and underlined our own assessment of a changing Asia and UVic's changing role in Asia. The review process led to a recommendation to take a thorough look at its future activity via a strategic planning process, which occupied much of 2011.

Robyn Fila joined us in November 2010, and quickly became an essential part of the CAPI team, working on the internship program. In May 2011 Heidi Tyedmers moved on after eight years of sterling work for CAPI as our Program Manager. We thank Heidi for all her wonderful work for CAPI and wish her all the best in her future endeavours. Heidi was able to place the internship program on a firm footing and her shoes have been filled very well by Robyn, who was fortunate to have a good lead-in period before taking over Heidi's position in mid-2011.

Our Lunch and Learn series continued to provide UVic and the community in Victoria with unique insights into Asia present and past, and attendance at these events increased greatly during the year. Notable other events were the visit and lecture by Vilsoni Hereniko, the Fijian writer and film director, organised in conjunction with the Pacific People's Partnership; and the visit and lectures by Chinese environmental activist Dai Qing; our conference on Human Security on China's Foreign Relations which brought about a dozen leading scholars from around the world to the University of Victoria. We were delighted to have Colin Jones from Doshisha with us as our Japan program visitor. Colin taught Japanese Law in the Faculty of Law, and organised an excellent seminar on Japanese legal reforms. A number of events were also organised for the benefit of students, such as the Graduate Symposium and the Global Engagement Showcase which celebrated International Development Week.

CAPI was established in 1987 as an important element of the University of Victoria's plan to expand and strengthen its links with universities and other institutions in the Asia-Pacific region, especially with China, Japan, Southeast Asia, Korea, and the developing island states of the Southwest Pacific.



# **CAPI Program Initiatives**

Wu Guoguang Department of Political Science and History and CAPI China Chair



China and Asia-Pacific Relations Program

During this reporting period, the CAPI China Chair was actively engaged in research, services, and outreach as well as teaching and graduate supervision with the Departments of Political Science and History. He was involved in numerous academic events and research trips, primarily including:

- Organization of a major international conference, visits of Chinese scholars, and a panel at the annual conference of the Canadian Asian Studies Association;
- Awarded 3 grants;
- Attendance at 11 conferences;
- Delivered 8 papers and 3 presentations;
- Served as a panelist and/or panel chair on different occasions;
- Refereed publications of 2 journal articles, 1 book chapter, 1 paper-back edited volume, 1 book review, and 10 non-refereed items;
- Traveled to China, Austria, Brazil, France, and Latvia, as well as other 6 trips in North America; and
- Served on CAPI committees as well as connecting with academic communities and international society.

In November 2010, with the award of a SSHRC conference/workshop grant, the CAPI China Chair organized a conference on 'Human Security in China's Foreign Relations'. Leading scholars came from China, Hong Kong, Britain, United States, and Canada to present their research update on issues such as climate change, environmental protection, water resources, food safety, pandemic control etc. and resulting implications for China's connections with the rest of the world. The China Chair then edited the conference papers into a volume, which will be published by Routledge in 2012.

The China Chair continuously sits on the editorial board of several international academic journals on Asia and China Studies, including China Perspectives/ Perspectives Chinoises (Hong Kong and Paris), China: An International Journal (Singapore), and East Asia: An International Quarterly (Durham, UK), East Asian Policy (Singapore), International Journal of Politics and Good Governance (Agra, India). He was invited to in the fall 2010 to join the Executive Committee of Editorial Board of the Journal of Pacific Affairs based at UBC.

During this period the China Chair was intensively interviewed and cited on various Asia- and China-related issues by Canadian and international media, which included: Dajiyuan (Feb 26, 2011), Radio France (March 8, 2011), The Economist (April 1, 2011), New Tang TV (April 30 and May 16, 2011) etc. Because of his engagement in commentaries of public affairs in China, at the end of the year 2010 he was listed by the Chinese websites 'Zhongyoujingzuo' as one of the '100 Chinese Public Intellectuals of the Year.' 

#### Research Project: Law, Governance and Constitutional Reform in Thailand

This project, which occupied most of available research time since the present chair joined CAPI in 2004, and especially in 2009-11, reached a critical outcome with a major publication, 'The Constitutional System of Thailand: a Contextual Analysis', co-authored with Peter Leyland, which was published by Hart Publishing in May 2011 when it was launched at a seminar at London Metropolitan University. This book marks the culmination of work involving a large number of research visits, conferences, poster sessions, and publications. During 2010-11 material from this project was published in the Journal of Political and Parliamentary Law, was delivered at a conference presentation in Singapore, and resulted in two published book chapters. This work has contributed to our understanding of the complexity and trajectory of the constitutional reform processes in Thailand during a particularly difficult and polarised period of Thai history beginning with mass protests against PM Thaksin Shinawatra in 2005 and ending with the violent dispersing of 'red shirt' protests in Bangkok in May 2010. Material from this project has been disseminated widely in poster sessions and teaching seminars over the last five years in Victoria (including a Dean's downtown lecture), Vancouver, Seattle, London, Leiden, Singapore, Melbourne, Wollongong, Chicago, Columbia North Carolina, Harvard, Kuala Lumpur, Shanghai, Xiamen, Bologna, Milan, and Siena, as well as Bangkok itself.

#### Thai judicial Training

In July 2008 the Faculty of Law and CAPI collaborated in delivering the first judicial training program to a group of 34 high level Thai

judges. The topic of this inaugural 10-day program was "Environmental Law". This training program was so successful that a second group of 30 judges visited in March 2009 for a shorter program on Criminal Justice, and in July 2010 the law chair directed another CAPI/ Law judicial training program. This program involved 42 Thai judges, and focused on "Juvenile and Family Law", covering principally youth justice and child protection. On this occasion we collaborated with the National Judicial institute of Canada, with other units on campus and officials of the BC government, and three days of the 10-day program were held in Vancouver. It involved visits to the youth detention facility, the Metchosin youth camp, and courts in Victoria and Vancouver.



#### Special Economic Zones in Asian Market Economies

On this project the law chair collaborated with CAPI Associate, Professor Connie Carter, whose full-time position is at Royal Roads University's Faculty of Management. In February of 2009, CAPI in conjunction with the Faculty of Law of Kyushu University in Fukuoka, Japan, organized a highly successful conference under the title "Special Economic Zones in Asian Market Economies: ['SEZAME'] What is Next for SEZs?" held at Kyushu University in Fukuoka. This project culminated in the publication of a book published in July 2010 based on the 2009 conference proceedings, Special Economic Zones in Asian Market Economies, published by Routledge. This publication was preceded by a CAPI Round Table, held at UVic in June 2010, involving some of the contributors to the book and including as keynote Professor Zeng Huaqun of Xiamen University in the PRC.

# CAPI International Internship Program

CAPI's International Internship Program continued to thrive over the past year with all fourteen of the 2010-11 interns completing their placements with great success. These internships received generous support from the Association of Universities and Colleges of Canada's Students for Development Program (for seven placements) and the Canadian International



Development Agency's International Youth Internship Program (for seven placements). Interns were based in progressive civil society organizations in Vietnam, Cambodia, and the Philippines, and were working on a range of issues from community development and conservation, to migration, and human rights.

In our 2012-2015 program, CAPI was thrilled to receive funding for an unprecedented three year program with funding for eighteen international internships through the Association of Universities and Colleges of Canada's Students for Development Program. These placements will see University of Victoria undergraduate and graduate students participating in dynamic placements in the Philippines and Bangladesh. With pre-departure training taking place in late 2011 and the first group of interns departing for their placements in early January 2012. This group of interns is scheduled to complete their placements in mid 2012 with the next group starting as they finish.


November 12, 2010

In 2010, CAPI's Hung Lecture was delivered by leading scholar, playwright and filmmaker, Dr. Vilsoni Hereniko, Director of the Center for Pacific Islands Studies at the University of Hawai'i, and newly appointed Director of the University of the South Pacific's Oceania Center for Arts and Culture.

This talk, which took place on the evening of November 12, 2010, attempted to explore the following questions: What does it mean to be human? What does it mean to be indigenous and why is it important to privilege one's indigenous roots? As we seek to celebrate our shared humanity, what must we seek to retain and protect at the same time? And finally, how might we translate the answers to these questions into our academic research, writing, and teaching in order to reinvigorate Pacific Studies in Oceania?

Originally from the village of Mea on the island of Rotuma, Vilsoni Hereniko is the author of *Woven Gods: Female Clowns and Power in Rotuma* and co-editor of *Inside Out: Literature, Cultural Politics, and Identity in the New Pacific,* as well as numerous scholarly articles, essays, plays, and films, including the feature film "The Land Has Eyes".

This lecture was part of Pacific Peoples' Partnership's "Pacific Wayfinders: 35 Years of Action and Solidarity" conference that took place from November 10 to 13, 2010. Over 100 Pacific Wayfinders & Changemakers engaged in the event & cultural celebrations. Inspirational stories of action, reclamation and perseverance emerged from robust discussions on environmental stewardship, governance, and the use of Indigenous knowledge in modern times. The Conference created a legacy of ongoing action that has enhanced collaborations locally within Pacific communities, and globally across the North and South.

# BC China Scholars Symposium 2011

April 9, 2011

This event was sponsored by the Centre for Asia-Pacific Initiatives, the Department of Linguistics, the Department of Pacific and Asian Studies, the Faculty of Humanities, the Office of International Affairs and University of Victoria. It explored topics such as "What Can Linguistics Offer to Chinese Language Teachers?"; "Painting a Modern Society: Westernizing Art Education in 20th Century China"; "New Electronic Resources for Research on China"; "China in the World; the World in China"; "Roundtable: China and the West - Thinking about The Other".

### Three Decades of Chinese SEZs: Old Roads and New Roads

"To end poverty, build a road", so goes a Chinese saying. SEZs, with their focus on massive infrastructurebuilding and labour-intensive manufacturing of low-tech goods exported to western markets, are the accepted drivers of China's rapid economic growth during the past three decades. The game began with the opening of coastal cities such as Shenzhen and Xiamen in 1980 and culminated with over 6,000 zones in the mid-1990s. Now, thirty years on, China's new development road includes exporting its old SEZ model to Africa, as well as upgrading its "Made in China" paradigm with an "Invented in China" wish.

Professor Zeng Huaqun, International Economic Law Institute, Xiamen University, China was the



keynote speaker at this Roundtable, which seeked to identify and discuss the key factors that have sparked this transition and the oxygen that may support China's new growth trajectory.

Other speakers/discussants included: Professor Connie Carter, Royal Roads University, Victoria, BC; Professor Feng Xu, UVic, BC; Professor Zhang Qianfan, Beijing University, China (currently Visiting Professor, UVic); and Professor Andrew Harding, CAPI, UVic, BC.

### Conference & Public Lectures: Human Security in China's Foreign Relations Featuring Dai Qing

#### November 2010

In November 2010, CAPI, with the support of the Pacific Institute of Climate Sustainability, was delighted and honoured to bring to the Univeristy campus to present a number of talks environmentalist Dai Qing. As a Probe International Fellow, activist and journalist, Dai Qing has been speaking out against the Three Gorges Dam since the 1980s. In 1989, she published *Yangtze! Yangtze!*, a book of essays highlighting the concerns about the environmental and social effects of the dam, followed by *The River Dragon Has Come!* in 1998. Though Dai Qing faces constant harassment by Chinese authorities and is forbidden to publish in China, she has chosen to remain in Beijing where she continues to fight for freedom of the press, government accountability, and an open debate over the Three Gorges Dam.

Dai Qing was the keynote speaker to the conference that brought together scholars to discuss "Human Security in China's Foreign Relations" at the University of Victoria in November 2010. Madame Dai gave two public lectures, tenaciously examining the intersection of the Chinese state, the country's path to development and the environmental repercussions. In her Keynote address entitled, "China's "Rise" and the Environment's Decline", Dai Qing bravely spoke out against the inequities of China's chosen path to development and offered a surprisingly candid discussion of all that is politically wrong with China today. The audience was amazed, particularly in light of Beijing having announced a few days earlier that it would not allow the release of Liu Xiaobo from jail in order to receive his Nobel Peace Prize. Despite international pressure, the Chinese government would not budge from their decision, creating a reminder of the political atmosphere of harsh authoritarianism that prevails in China. Not one to let an opportunity pass her by, Dai Qing in solidarity with her fellow political activists explained to the audience that for all of China's economic gains, much politically has remained the same over the past 2000 years.

Dai Qing's second public lecture, "On the Completion of the Three Gorges Project", was a examination of the failure of the Three Gorges Dam. By analyzing hydropower generation, flood control, navigation, resettlement, water pollution and geological disasters, weather impact and the project's budget, Madame Dai was able to offer the audience a poor report card, more than twenty years after her first public protest against the dam.
