UVIC DONOR (General) Awards (Science Students amongst others):

Category A – available only to students in SEOS

Gagnon Memorial Scholarship (\$875) - one or more scholarships are awarded to full-time students pursuing graduate studies at the MSc or PhD level in the Earth and Ocean Sciences program. Preference will be given to students working in the area of physical oceanography, ocean circulation, ocean turbulence, air-sea interaction or sea level change.

Briefly explain what makes you a strong candidate for the Gagnon Memorial:

Category B – available to several specific departments/schools or to all departments/schools

Albert Hung Chao Hong Scholarship (\$8400 for one or more scholarships) – annually presented to academically outstanding UVIC students who are citizens of Hong Kong or Mainland China.

Briefly explain what makes you a strong candidate for the Albert Hung Chao Hong:

Edward Bassett Family (\$2000 for two scholarships) - awarded to grad students whose programs focus on any of the following areas: resource conservation, resource management, environmental impact, pollution control, or environmental sustainability. One of the two awards may be given to a student who holds a major fellowship.

Briefly explain what makes you a strong candidate for the Edward Bassett Family:

General Graduate Scholarships (\$\$ varies) – annually presented to generally outstanding graduate students entering or continuing in Graduate Studies.

Briefly explain what makes you a strong candidate for the General Graduate:

Charles S. Humphrey Graduate Student Award (\$2500 ea) ~ 7 awards available this year. Annually presented to highly qualified candidates in the Faculties of Science and Engineering.

Briefly explain what makes you a strong candidate for the Charles S. Humphrey Award:

Commander Peter Chance MASC Graduate Fellowship (\$8000) – an annual fellowship is awarded to a student pursuing graduate studies at the Masters or PhD level in an area pertinent to Canada's maritime interests. Priority will be given to studies on ocean-related topics within such fields as history, economics, sociology, policy, engineering and science. The fellowship is tenable for a maximum of two years, but may not necessarily be offered in any given year.

Briefly explain what makes you a strong candidate for the Peter Chance MASC fellowship:

Martlet Chapter IODE Graduate Scholarship for Women (\$375) - annually awarded to a woman student with high standing who is entering her 2nd year of a MSc program.

Briefly explain what makes you a strong candidate for the Martlet Scholarship for Women:

Alfred and Adriana Potvin Graduate Scholarship in Ocean Science (\$2800) - awarded to outstanding students in the School of Earth and Ocean Sciences who are pursuing an MSc or PhD in Ocean Sciences or an MSc or PhD in Marine Biology in the Department of Biology. The Awards Committee of the Faculty of Graduate Studies will make selection of the recipients.

Briefly explain what makes you a strong candidate for the Potvin Graduate Scholarship:

Cassels Shaw Graduate Fellowship (\$7200) – 1 or more awarded to outstanding graduate students. Recipients are selected on the basis of high academic achievement and demonstrated financial need. Applicant must complete a budget assessment form (see Grad Secretary for this).

Briefly explain what makes you a strong candidate for the Cassels Shaw Fellowship:

Howard E. Petch & David S. Strong Research Scholarships (\$7500 each) - only granted to Graduate Students who hold a UVIC Fellowship valued between \$15K and \$18K or major Canadian National Award valued between \$15K and \$25K. If a nominated and successful student holds a President's Research Scholarship (\$4,000) it would have to be forfeited for that student to accept the Petch or Strong.

Briefly explain what makes you a strong candidate for the Petch & Strong Scholarship:
