Text : There is no required text book for this intensive 4th year course. The expectations are for attendance in every class as well as ongoing participation in class activities. **ATTENDANCE WILL BE TAKEN.** When appropriate, handouts will be distributed by the instructor.

Course Description “Forensic Psychology - Forensic psychology is the interface between psychology and the law, so all psychological services provided for the legal community are forensic psychological services. However, most forensic psychologists provide services which are both clinical and forensic in nature. When a psychologist treats an individual who was emotionally traumatized by an accident, the treatment is clinical in nature ... But, when the psychologist is asked to provide a report for the court, regarding the extent of the trauma, and to assess the psychological damage incurred, then the psychologist is providing forensic services” (Franklin, 2006). Topics covered in this course will include but not be limited to: victimizers and victims, anger management, violence and violent offenders, abuse and sexual offenders, juvenile offenders, male offenders, female offenders, mental health, mental handicap, and dual diagnoses. Crime, deviance, and justice issues will be examined.

Prerequisites

The prerequisites for this course are PSYC 300A, and 300B as a co-requisite. Students who remain in courses for which they do not have the prerequisites do so at their own risk. Those who complete courses without prerequisites are not exempt from having to complete the prerequisite course(s) at some later date if such courses are required for the degree program.

Students will be graded on their performance on 3 exams, a number of group assignments and a major paper.

1. Exams

Knowledge of any relevant readings / handouts and lectures will be assessed through **THREE** exams. The take-home exams will include questions based on case studies and general class knowledge. The in-class exam will include short answer/essay questions based upon key factors, processes, and concepts discussed in class as well as information gleaned from the reflections and round tables. It is the student's responsibility to attend in-class exams as scheduled. Students who miss an in-class exam will receive a mark of zero unless they have a case of documented illness or family emergency. **PLEASE RECOGNIZE THAT, DUE TO MY TEACHING SCHEDULE, THERE CAN BE NO EXTENSIONS FOR MISSED WORK, INCLUDING EXAMINATIONS.**

2A. Major Paper

Each student will submit a formal academic paper (9 to 12 pages in length in APA formatting) with peer-reviewed research on a topic of choice. This topic **MUST BE APPROVED BY THE INSTRUCTOR** by July 7th. If approval is not sought on time then the written paper will not be accepted. Key areas of interest and research include the concepts of *competency, mental health disorders, divorce and child custody (or animal custody is also of interest but not often considered), eyewitness testimony, and memory for events* to name but a few. **THE PAPER IS DUE BY JULY 21ST AT THE LATEST; HARD COPY SUBMITTED IN CLASS.** No extension will be granted.

2B. Short Oral Presentation

Each student will give a short (10 MINUTES) oral presentation to class on key ideas / takeaways from their paper. Handouts are permitted (I can make copies for everyone.) These will run July 24, 25, 26 (or earlier if the paper is submitted before July 24th and the student chooses to present before July 24th). A good approach is: This is what I've learned ... I was surprised to find out that ... key takeaways for me included the following ...

3. Reflections and Round Tables

Beginning July 5th and then on July 7,10,12,14,17,19, and 21, each student will submit, at the end of class, responses to specific questions raised by the instructor in class (2% each). These may include responding to items in a handout. These discussions cannot be made up if a class is missed.

The final letter grade in the course will be based on total percent score rounded to the third decimal point as shown:

Note:

Failure to complete one or more of these elements will result in a grade of "N" regardless of the cumulative percentage of all other elements of the course. N is a failing grade and factors into GPA as a value of 0.

5. **Cheating on Assignments, Tests, and Examinations.** You may not copy the work of others in or out of class; you may not give your work to others for the purpose of copying; you may not use unauthorized material or equipment during examinations or tests; and you may not impersonate or allow yourself to be impersonated by another at an examination. The Department of Psychology has a policy of not making old examinations available for study purposes. Therefore, use of old exams without the express written permission of the instructor constitutes cheating by the user, and abetting of cheating by the person who provided the exam.
6. **Aiding Others to Cheat.** It is a violation to help others or attempt to help others to engage in any of the conduct described above.

Do not apply at Records Services for a “Request for Academic Concession”. Instead, contact your course instructor (or designated teaching assistant) to let them know why you missed the exam. Medical documentation is not required.
- **What to do if you require additional time to complete course requirements**
Apply at Records Services for a “Request for Academic Concession”, normally within 10 working days of the end of the course. Records Services will forward the form to the instructor.
