What is Enhanced Planning?

- Evidenced-informed decision making
- Transparent resource allocation
- A way to align resources (money, space, time, people) with strategic priorities
- In short: a way to enhance our existing planning processes with qualitative and quantitative measures that are consistent and transparent campus-wide



What is the scope of the first phase of the project?

- Develop campus-wide criteria (complete)
Context, Quality, Demand, Productivity and Efficiency, Financial Considerations, Impact and Essentiality, Opportunity Analysis
- Identify the unit of measure (complete)
- Identify data sets and qualitative measures to help determine progress in each of the units within each of the criteria (underway)
- Collect data both quantitative and qualitative (how and when under discussion)



What is the 2014/15 Timeline?

- Fall Semester
 - Complete suggested draft data sets for Quality, Demand, Productivity and Efficiency, and Impact and Essentiality (Working Group and Advisory Committee)
 - Begin collecting data on Financial Considerations (Dean's Offices and data from FAST)
 - Reach agreement on developing software to collect, store and report the institutional data set (Working Group and Systems)



- Spring Semester 2015

- Consultation and feedback on suggested data sets for all criteria (constituent groups across campus)
- Complete data collection on Financial Consideration
- Design and test software
- Possible collection of qualitative data from units (as possible as software package is developed)
- Prepare and distribute reports to units (as possible as software package is developed)
