# **Course Objectives**

The objective of this course is to provide students with the basic skills needed to analyze, formalize, and solve diverse medical imaging problems from an image processing viewpoint.

## **Learning Outcomes**

By the end of the course, students will be able to:

- lead an in-depth discussion on the challenges that medical imaging modalities (X-Ray Imaging, CT, MRI, ultrasound) impose on image processing algorithms.
- design and implement algorithms for data visualization, noise reduction, contrast enhancement, image segmentation, and object recognition within the context of medical imaging.
- design, implement and evaluate a multi-step medical image processing approach.

- Noise in medical images. Algorithms for noise reduction.
- Image enhancement and applications to medical images.
- Image registration and applications to medical images.
- Image segmentation and applications to medical images.

- Pattern recognition in medical images deep learning paradigms.
