Course Objectives

To provide understanding of the principles and practice of designing and implementing real-time computer systems and applications.

Learning Outcomes

- 1- Illustrate the characteristics of real-time computer systems.
- 2- Use experimental and production real-time operating systems.
- 3- Design and Implement application and environment to ensure processing deadlines are met.
- 4- Justify the hardware support in real-time systems.
- 5- Assess hazards in real-time mission-critical systems.
- 6- Design and validate the requirements of a real-time system.

Syllabus

The characterization of a Real-Time Computer Systems. The significance and management of Time, Fault-Tolerance and Environmental Integration. The major part of the course will concentrate on the management of time as a computational resource. Several techniques including rate-monotonic scheduling, deadline scheduling, time-driven scheduling, etc. will be discussed. Several experimental and production Real-Time kernels will be examined. A dedicated focus on the FREE RTOS will be applied in the Laboratory, as all projects will be built using this Real-Time Operating System.
