IMPORTANT: Please watch for updates on the Faculty of Education website (www.uvic.ca/education/areas-study/teacher-ed) - changes to these admission requirements are expected for September 2020 program entry.

Program admission requirements

1. Admissibility to the university. The Undergraduate Admissions and Records office determines eligibility for admission to UVic.
2. An acceptable undergraduate Bachelor's degree recognized by the University of Victoria.
3. 3 units of approved English (literature and composition or all literature).
4. Demonstrated competency in written English (grade requirement; see page 2).
5. A sessional grade-point average (GPA) of at least 3.00/9-point scale (UVic C+). See page 2.
6. A 30-unit GPA of at least 3.00/9-point scale (UVic C+). See page 2.
7. Approved academic studies in one or two teachable subjects relevant to the BC curriculum. The list of available subjects is provided on the program website at www.uvic.ca/education/curriculum/undergraduate/home/programs/secpdpp.
8. A minimum GPA of at least 4.00/9-point scale (UVic B-) on the specified courses in each teachable subject area (see below).
9. Applicants must describe their learning and teaching goals, relevant experience, skill, and interest in working with youth in educative ways via supporting documents (such as a statement of intent, résumé and two reference forms). Eligible applicants may also be invited to attend an interview.

Notes

- A 1.5-unit course (equivalent to 3-4 credits at most institutions) meets for at least 3 hours per week for 13 weeks (one term).
- **At UVic, 'upper-level' refers to 300 and/or 400-level courses normally taken in third and fourth year after introductory studies.**

Teachable subject area: Music

The UVic Music Education Experience

Admission with a music teaching area requires UVic's Bachelor of Music degree with a major in music education (secondary) or an equivalent degree. The major in secondary music education is unique; therefore, if you've completed a BMus elsewhere or a different music major from UVic, be prepared to take additional music education and music courses at UVic before applying for Secondary PDPP admission. It may take two or more academic years to complete the necessary courses.

All of the UVic courses listed in Sections A and B as well as 3 units of approved English are required for entry with the music teaching area. If you believe you've completed equivalent courses elsewhere, please list them in the applicable section. After you've completed filling out this form, consult a Faculty of Education Academic Adviser. Please provide the adviser with a copy of your transcript(s) and descriptions of any courses you've listed as 'equivalent' below. **The Adviser will consult with Faculty of Education Music Education Adviser Dr. Anita Prest and School of Music Adviser Dr. Gerry King and then notify you regarding the review outcome.**

Prior to registration in courses, you should contact the School of Music for registration assistance in reserved course sections. Registration approval will depend on the availability of seats after Bachelor of Music program students register.

An admission interview will be scheduled by the School of Music in the spring term of the first year of music education courses. You must successfully pass this interview in order to be eligible to continue in the required music courses and apply for entry to the Secondary Post-Degree Professional Program with a music teaching area.

Please indicate if you plan to apply to the Secondary PDPP with a **choral emphasis** or **instrumental emphasis**.

Minimum Grade Point Averages

To be considered for selection by the Faculty, you'll need:

- An average of at least 3.00¹/9-point scale on the most recent 30 units attempted to December 31. This GPA will be a factor in selection for program admission.
 - An average of at least 3.00¹/9-point scale on the most recent sessional GPA of at least 12 units attempted to April 30.
 - An average of at least 4.00²/9-point scale on specified courses included in the teachable subject area(s).

- Grade point average conversions from other institutions and calculations are done by Undergraduate Admissions and Records upon application.

¹ 3.00 on UVic's 9-point scale is equivalent to C+ (UVic 65 – 69%).

² 4.00 on UVic's 9-point scale is equivalent to B- (UVic 70 – 72%).
