The Design Project course provides you an opportunity to acquire formal design experience by working on a project in a team. You and your team mates will select and execute a project approved and supervised by a faculty member. You will also a get an opportunity to demonstrate your work to general public towards the end of the term.

Intended Learning Outcomes

By the end of the course, you should be able to

- Formulate a problem definition and design objectives for a design activity based on the requirements and constraints imposed by the client/stakeholder.
- Plan project timelines with milestone dates and activities.
- Generate and evaluate conceptual design ideas by performing a detailed literature review.
- Explain the social implications of the proposed engineering work.
- Apply appropriate mathematical methods for the analysis of the engineering design.
- Participate effectively in teamwork during engineering design.
- Produce a functional prototype or perform extensive simulation of the design.
- Test, evaluate and document the performance of the prototype.
- Prepare professional reports detailing the design activity.
- Create a webpage to publicize the design activity.
