MESSAGE FROM THE DIRECTOR

It has now been a term since I began

my role as Director of the School in January 2015. It has been a busy but rewarding term for me. First of all I would like to thank Dr. Abdul Roudsari for his directorship of the School over the past five years. Enrollments at both the undergraduate and graduate levels are up and there have been many interesting developments. In February the School hosted the biannual ITCH (Information **Technology and Communications** in Health) conference with over 150 attendees from around the world. This conference, chaired by Dr. Roudsari, has led to the edited IOS Press publication "Driving Quality in Informatics: Fulfilling the Promise" edited by Drs. Karen Courtney, Alex Kuo and Omid Shabestari (copies are available through the School for a reduced cost).

In other developments, in the fall of last year Dr. Francis Lau was inducted into the Canadian Academy of Health Sciences (CAHS), and Dr. Elizabeth Borycki completed her terms as Canada's Academic Representative for COACH and as a VP at the International Medical Informatics Association. Finally, Dr. Scott MacDonald published important work showing the new legislation on drinking and driving has been saving lives in our province.

In the HINF office we have Sandy Polomark (his@uvic.ca) as office manager and assistant to the director and Sandra Boudewyn as graduate program assistant (hisgrad@uvic.ca). Silvia Dulc is also working with us as our administrative officer. For co-op, Dave Hutchinson (hiscoop@uvic.ca) and Debbie Robertson are still onboard and always looking for co-op leads and potential opportunities for student co-ops.

The School is happy to be producing this newsletter. We plan to follow up with newsletters on a regular basis. Mowafa Househ (PhD '09) has received one of the most prestigious awards in the Middle East for social entrepreneurship for his work on Crowd Funding Weight Loss On-line Platform

This project is one that aims to develop a unique and innovative crowdsourcing platform for weight loss in Saudi Arabia and the Arab World. Crowdsourcing is "the practice of obtaining needed services, ideas, or content by soliciting contributions from a large group of people and especially from the online community rather than from traditional employees or suppliers". The project is trying to harness the "wisdom of crowds" to help develop a tailored weightloss solution for people to achieve their weight loss goals by bringing a team of nutritionists, behaviorists, and fitness experts, or ordinary people with weight loss experience to work with them. Specifically, the target is overweight or obese individuals with unsuccessful experience to lose weight, and this platform is built around the concepts of patient empowerment which allows the client to choose from a list of experienced weight loss experts.



Mahmood Tara

Mahmood Tara (PhD '08) is the director and faculty member of the Department of Medical Informatics at Mashhad University of Medical Sciences, Mashhad, Iran.

In October 2014 he was elected as the chair for the National Board of Health Information Management and Informatics (NBHIMI) at the Iranian Ministry of Health.

Every two years, all medical universities are asked by the Ministry of Health and Medical Education to introduce their scholars in every branch of medical and paramedical sciences. Such lists of scholars are then reviewed by a superior committee and eleven people are selected as Board members based on their final rank. In the first official meeting, the board members vote for the candidate members nominated for the chair position. The result of voting is directly reported to the Minister. Finally, the chair is officially appointed by the Minister of Health for a two year term.

NBHIMI is responsible for the supervision, planning, and evaluation of all Health Information related academic programs in Iranian medical universities. There are currently more than twenty MSc and PhD programs in the field of Health Information Management and Medical Informatics in Iran, whose students are selected through a very competitive annual national exam.

Fundraising

Just a bit of a background of myself - I moved to Victoria in 2006 and came into HINF right away. I completed the program back in 2010, and since then have been working as a clinical application analyst in Vancouver where I work with a lot of HINF alumni. I grew up in Nepal, where my dad did development work and my mom was a neurosurgical nurse (my mom is Nepali and my dad is Hungarian). We moved to Canada during the Maoist revolution several years ago. All of my family on my mom's side still lives there - cousins, aunts, uncles, etc. While thankfully everyone has been accounted for in our family so far, many are not living in great condition now or have limited access to water and food still, and some of our family friends have either not been accounted for or have not survived the earthquake. It has been very traumatizing on our whole family, and the rest of Nepal.
