Ex-empires aid former colonies

France, the UK, Belgium, Spain and Portugal, the countries with the largest colonial empires until the middle of the 20th century, are spending their Official Development Assistance (ODA) largely in countries which were their colonies.

The top 7 countries receiving **French** ODA are Morocco, China, Vietnam, Cote d'Ivoire, Colombia, Senegal and Kenya. Of those, only China, Colombia and Kenya were not French colonies.

The present - Cotonou Partnership Agreement (2000-2020)


- **Objective** reducing and eradicating poverty consistent with the objectives of SD and the gradual integration of the ACP countries into the world economy (A.1).
- **Principles** partnership, aid effectiveness, equality & ownership, participation, mutual accountability(A.2).

EU Budget Support

Purpose - "Better aid and achieving sustainable development results" (Guidelines 2012: 11)

Based on

- Dialogue
- Financial transfers to the state's national treasury account
- Performance assessment
- Capacity development

Three kinds

(i) **Good Governance and Development** contracts; (ii) **Sector reform** contracts and (iii) **State building** (development or reform policy or strategy)

Based on

Eligibility Criteria

- National/sector policies and reforms
- Stable macro-economic framework
- Public financial management
- Transparency and oversight of the budget

Process

- Assessment pre- (relevance and credibility)
- And during ongoing monitoring and reporting (of progress)

States' subjectivity, sovereignty and performativity

- 'the state' discursive production; structuring effects and performativity.
- What of heterosexual assumptions behind gendered readings of the state?
- Cross-dressing = 'thomacy'?
- Andlegacy of colonisation?

Potential of thomacy and performativity

- Implies a non-chronological understanding of **time**
- **Contingent** nature of key concepts e.g. state; 'failed' state; good governance; developing country etc.
- Performativity and **co-creation**
- **Continuities** in discourses of civilisation & progress (colonisation) and order and progress (contemporary)
- International governance instruments law, legality, technocratic, bureaucratic and knowledge
- EU significance of its values to its wielding of power
- Discourse more powerful **BECAUSE OF** colonial past

Limits

- Of scope of application to EU foreign policy/ external relations
- Context of current literature on Cotonou
- Method/schmethod
- Definitions of gender, cross-dressing
- Links with colonisation laws rules
- Resistance and violence

Elision - definition (OED online)

Late 16th century: from <u>late Latin</u> *elisio(n-)*, from <u>Latin</u> *elidere* 'crush out'

- The <u>omission</u> of a sound or <u>syllable</u> when speaking
- The process of joining together or <u>merging</u> things, especially <u>abstract</u> ideas
