### I-WITNESS FIELD SCHOOL

The purpose of the Field School is to explore the ways in which the Holocaust is memorialized in Central Europe and to build an understanding of how the lessons of the Holocaust are relevant in today's world.

Students in this 3.0-unit, 400-level undergraduate course have the opportunity to acquire a deeper understanding of antisemitism, racism, religious intolerance, homophobia and the stigmatization of the mentally and physically disabled communities. Graduate students will register for GMST 589, which is a 1.5-unit course.

### ITINERARY/PROGRAM INFORMATION

The course begins with one-week of intensive study at UVic starting on May 6, 2026. This is followed by three weeks in Europe (Germany, Poland, and Austria) ending on June 7, 2024. Participants have until August 1, 2024, to complete their post-travel assignments.

#### Deposit and Payment Schedule

Total program costs (on top of tuition, round-trip travel, insurance, and food costs) = \$3,000 (CAD)
