# WHAT IS A PGWP?



# A PGWP IS...

- An open work permit
- Allows you to gain Canadian work experience after graduation (e.g., full-time, part-time, selfemployment)
- Possible occupational restrictions (e.g. health care, primary/secondary school, childcare)
- Can only be issued once per lifetime

# WHO IS ELIGIBLE FOR A PGWP?

#### Some PGWP Criteria:

- Complete an eligible program in Canada that's at least 8 months in length
- Continuous full-time enrolment in all regular academic sessions except for <u>authorized Leave of Absence</u> or final term
- If distance learning is allowed, it must not exceed 50% of your program

If applying from inside Canada, please ensure you have a valid study permit at the time you apply.

# **UVIC DEFINITIONS & PGWP ELIGIBILITY**

- Full-time Definitions at UVic
  - ✤ Undergraduate Calendar
  - ✤ Graduate Calendar
- Regular Academic Sessions
  - Winter sessions (September to April)
  - Summer session (May to August)

Summer Session

- Graduate students: Summer is not a scheduled break as you are required to maintain continuous enrollment.
- Undergraduate students: Check with your Academic Adviser to confirm if your program includes a scheduled break in summer.

# POST-GRADUATION WORK PERMIT VALIDITY

A PGWP can be granted for a minimum of 8 months to a maximum of 3 years.

- 8 months to < 2 years = the length of the program completed (\*Exceptions for grad students may apply)
- 2 years or longer = 3 years

## **COVID-19 SPECIAL MEASURES**



#### FACILITATION MEASURES: PART-TIME STATUS

- Students in Canada or outside of Canada may have been required to put their studies on hold or become part-time students due to course cancellations that were the result of public health measures at DLIs.
  - For the winter, spring and summer semesters of 2020 only (that is, between January 1, 2020, and August 31, 2020), if a student's status changed from full-time to part-time because of changes in course delivery at a DLI, their eligibility for a PGWP will not be impacted.

#### FULL FACILITATION MEASURES: DISTANCE LEARNING

- All students who were enrolled in PGWP-eligible programs in March 2020, or who started a program of study between March 2020 and August 31, 2022, are not required to complete 50% of their program (or programs) of study in Canada.
  - Up to 100% of their program can be completed online from outside Canada.
- For the above group of students, up until **December 31, 2023**, time spent studying outside of Canada can be counted toward the overall length of the PGWP.

#### **REDUCED FACILITATION MEASURES: DISTANCE LEARNING**

All students who started or will start a program of study between September 1, 2022, and December 31, 2023, are required to complete at least 50% of their program (or programs) of study in Canada.

• For the above group of students, up until **December 31, 2023**, time spent studying outside of Canada will be counted toward the overall length of the PGWP only if it constitutes less than 50% of the program.

\*Any time a student spent studying outside of Canada **after** December 31, 2023, and any time spent studying outside Canada before applying for a study permit, will be deducted from the length of the PGWP, regardless of when the student started or will start their program of study.\*

# APPLYING FOR PGWP



## HOW TO APPLY FOR A PGWP

- Apply online
- In Canada: apply within 90 days after you receive your final grade AND have a valid study permit at the time of application
- Outside Canada, you can apply within 180 days after you receive your final grade.

## **DOCUMENTATION REQUIREMENTS**

- Degree completion letter
- Official transcript or Administrative transcript from UVic Online tools.
- Valid passport
- Digital photo
- Credit or debit card to pay your fees online
- Medical exam (if applicable)
- Biometrics (if applicable)

## **PGWP APPLICATION TIPS**

- <u>Apply for graduation</u> in your final term.
- Only request a degree completion letter when your final grade is available in your UVic Online tools.
- Only submit your PGWP application when you receive UVic documents (a degree completion letter AND final transcript).
- Consult the Instruction Guide [IMM 5580] as needed.
- Read the questions carefully and answer them honestly.

## **PGWP APPLICATION TIPS**

- Online applications are saved in your IRCC secure account for up to 60 days only.
- Keep paper or electronic copies of your application form and supporting documents.
- Take screenshots at different stages.
- Monitor your application status online.
- Consult us before you submit the application if you have questions.
- Use <u>IRCC Web Form</u> to raise questions if needed.


#### Federal Court certifies Government of Canada privacy breach class action





- Can I work while my PGWP application is being processed?

## FAQS CONTINUED...

- Can I travel outside Canada while I have a PGWP application being processed in Canada?
- Do I need to have a job in order to keep the PGWP valid?
- Can I renew a PGWP?
- How can I prove to a potential employer that I am eligible to work while I await processing of my application? (<u>IRCC</u>)
- Can I apply to extend my family members' status while I apply for a PGWP
  - Open Spousal Work Permit eligibility
  - <u>Changes to open work permit eligibility for family members of</u> <u>foreign workers</u>
