### Additional Points to Note:

- Further information regarding summer term will be posted in January. Summer term is **optional** for non-co-op students.
- Typically Law Co-op students are expected to attend one academic summer term during their legal studies. Students who completed first-year law in April 2022 and are following Schedule Options 1 and 2, as set out in the Law Co-op Handbook, are reminded that they are scheduled to be on campus for courses in fall 2022 and summer 2023. They will be on work terms in spring 2023. Law-co-op students have priority course registration in summer term.
- UVic JD students who commenced the JD program in September 2019 or later must successfully complete the compulsory courses LAW 301 Administrative Law and LAW 360 Legal Ethics and Professionalism during their upper-year studies.

- Co-op students and students opting to register in summer term are encouraged to take these required courses in summer 2023. Some co-op employers prefer to hire students that have taken LAW 301 Administrative Law, so co-op students interested in these placements may choose to register in Administrative Law in an earlier term.
- Co-op students expected to be in school in summer 2023 according to their co-op rotation schedule are encouraged to take 7.5 units in fall 2022 since course selection in summer term is limited. Reminder: The second-year credit requirement for full-time law students is 14.5 units.
- JD/JID students are not generally eligible to take summer courses due to the JD/JID's required transsystemic courses being offered solely in Winter Session. Students with extenuating circumstances may contact the Associate Dean, Academic and Student Relations to determine whether an exception can be made.
