Funding opportunities

Operating Grant: CIHR New Investigator Grants in Maternal, Reproductive, Child & Youth Health

This funding opportunity to support New Investigators in Maternal, Reproductive, Child and Youth Health is a collaboration between seven CIHR institutes. The goal of the program is to build research capacity in maternal, reproductive, child and youth health by funding operating grants to new investigators. The program will fund research across the four pillars (biomedical, clinical, health systems services, and population health) that has the potential to have a significant impact on maternal, reproductive, child and youth health outcomes according to the mandates of the participating CIHR institutes. Ultimately, the program aims to strengthen Canada's capacity and knowledge to respond to challenges and needs by providing important early career development support to researchers in these fields. IAPH will provide funding to applicants undertaking maternal, reproductive, child and/or youth health research relevant to the institute's mandate.

Fellowship: Health System Impact Fellowships (CIHR)

The specific objectives of this funding opportunity are to: support impact-oriented career paths and elevate the career readiness of individuals with a PhD in HSPR or related fields by supporting experiential learning opportunities in Canada outside of the traditional scholarly environment, enriched competency development (e.g., leadership, project management), and national cohort participation; expand and enrich the traditional post-doctoral training environment by engaging health system and related organizations in preparing a cadre of promising PhD graduates for successful careers; provide health system and related

organizations with direct opportunities to realize and harness the benefits that PhD-trained individuals can bring to such organizations for improved decision- making. In order to be considered relevant for CIHR-IAPH funding, applications must align with its mandate and specific Health System Impact Fellowship objectives, as outlined in the Internal Collaborator section.

Team Grant: Healthy Life Trajectories Initiative (HeLTI) – Canada (CIHR)

The goal of HeLTI is to generate evidence that will inform national policy and decision-making in Canada and the participating countries for the improvement of health and the prevention of non-communicable diseases (NCDs), with an emphasis on obesity, cardiovascular disease and diabetes throughout the lifespan. Given that both maternal and paternal health have transgenerational effects on development and health of offspring, this funding opportunity also aims to develop gender-responsive evidence for interventions and policies aimed at the needs of men, women, boys and girls. The engagement of multiple countries will promote valueadded international collaborations through a multifaceted, multidisciplinary approach to the problem by spanning basic science to public health research and policy, which will position the initiative to have significant long-term impacts on global health. The specific objectives of this funding opportunity are to: Develop a new linked DOHaD intervention-risk cohort composed of a representative population, including recruitment of women both preconception and during pregnancy, their infants, as well as the fathers; Develop and conduct implementation, as well as evaluate implemented interventions for, and with, women and men preconception, during pregnancy and for infants during the postnatal period that are designed to substantially reduce the prevalence of NCDs; Conduct evaluation and mechanistic studies that will explain the effect of the selected interventions on outcomes, including economic analyses of interventions; As part of the international HeLTI initiative, develop international multi-country, multi-disciplinary, cross-site collaborations that will provide a learning platform and training environment for new investigators and/or early career stage researchers, support data interoperability and improve harmonization practices; Generate evidence that will guide policy and other decision-making, and identify opportunities for future research and interventions as part of a longer-term strategy for NCD prevention; Improve health outcomes, particularly related to women and men's health preconception, during pregnancy, early life and childhood by targeting early exposures and early development.

Team Grant: HIV/AIDS Comorbidities Prevention and Healthy Living

The relevant research areas for this funding opportunity are: HIV and Aging; HIV, Mental Health and Neurological Conditions; Co-morbidities associated with HCV or other Sexually Transmitted and Blood-borne Infections (STBBIs) in people living with HIV/AIDS. Note: Research may include domestic and international aspects. However, the focus of the project must be on the disease/condition within the context of HIV/AIDS in Canada. Applicants applying to the Indigenous populations funding pool must have at least one knowledge user that self-identifies

as either First Nations, Inuit or Métis or provide evidence of Indigenous-living experiences (i.e. demonstrating close relationships and experience with First Nations, Inuit or Métis people such as living and/or working an extended period of time (e.g., 5 years or more) with an Indigenous community). The total amount available for this funding opportunity is \$12,750,000, enough to fund approximately 5 grants. This amount may increase if additional funding partners participate. The maximum amount per grant is \$500,000 per year for up to five years for a total of \$2,500,000, per grant. Of this \$12,750,000: \$2,500,000 is available to fund an application that focuses exclusively on First Nations, Inuit, Métis and/or Urban Indigenous populations. Developmental grants of up to \$25,000 per grant may be offered, if requested, to successful applications at the Letter of Intent stage. The total amount available at the LOI stage is \$250,000.Of this \$250,000: \$50,000 is available to fund applications that focus exclusively on First Nations, Inuit, Métis and/or Urban Indigenous populations.

Team Grant: HIV Implementation Science – Component 2

The CIHR HIV/AIDS Research Initiative and its partners have developed the Implementation Science for the Prevention of HIV, Hepatitis C (HCV) and Sexually Transmitted and Blood-Borne Infections Initiative in order to address the gap that exists in the application of evidence into health policy and programs. The goal of the initiative is to reduce the incidence of HIV, Hepatitis C (HCV) and other sexually transmitted and blood-borne infections (STBBIs) within and across key populations in Canada. The submitted project must demonstrate specific relevance to the prevention of HIV. Component 1 – Adaptation Grants: nine grants were funded to support the development of multi-sectoral teams, to identify promising or effective interventions and develop multi-faceted programs through intervention adaptation. Component 2 -Implementation Grants: will support teams to facilitate the multi-year investigation of program implementation and/or scale-up across multiple heterogeneous communities. These teams must meaningfully engage people living with HIV, HCV or other STBBIs, decision makers, community leaders and researchers from different research disciplines. Together, these multisectoral teams will identify target populations and focus on the identification, adaptation and equitable scale-up of promising or effective interventions across diverse settings/contexts for the prevention of HIV. Catalyst Grant: HIV/AIDS Community-Based Research

In the Indigenous stream, applicants are advised to focus on indigenous populations and in particular, Indigenous knowledge systems and Indigenous-living experience. Indigenous-living experience is a quality demonstrated by individuals who are closely connected with First Nations, Inuit and Métis communities. Examples of how applicants applying to the Indigenous stream may wish to address this focus within their application include: prioritizing First Nations,

Inuit and Métis Peoples and communities in their research agenda; promoting cultural safety and appropriateness of researchers working in Indigenous health; adding value to the research through culturally relevant analysis of results; promoting equity and build capacity of Indigenous trainees and researchers in Indigenous Health. For non-Indigenous researchers applying to the Indigenous stream, Indigenous-living experience may be acquired through special circumstances such as close relationships and experience with Indigenous People, living an extended period of time (e.g., 5 years or more) on a reserve, in an urban environment such as a Friendship Centre, in a Métis or Northern community, or through similar experience with other Indigenous Peoples – e.g., Pacific Islanders, or South American Indigenous Peoples.
