CFGS research considers the nexus of the local and global—how local concerns have global effects and how global issues manifest at the local level. Our fellows and researchers are exploring issues vital to people, places, policy and the planet and are making an impact around the world. We have specific interests in the following areas:

- Borders and migration in the 21st century
- Environmental and social policy, and ecological governance with a strong emphasis on water
- Indigeneity and reconciliation from global and local perspectives
- Social justice and participatory democracy
- Governance as an integrated process at and across scales

On the pulse of current events

The CFGS hosts conferences, workshops and speakers that promote critical citizenship in a complex and rapidly changing global environment and respond to defining events as they unfold. These events bridge the divide between academia and the community, as well as inform policy, decision makers and citizens on important issues.

Projects and programs

We collaborate on projects across faculties and departments at UVic as well as with communities, practitioners, partners and universities around the globe. These projects reflect the core themes of the Centre and bring together diverse groups of people to communicate our research through events, publications and collaborative networks. We make our boundary-pushing research accessible to policy makers, researchers and the wider community.

Fellowship program

The Centre awards fellowships to graduate students, international scholars and faculty researchers with an overarching aim to build a sophisticated and transdisciplinary network. These fellowships provide office space, a stipend for students/visiting scholars, and course and administrative release for faculty ranging from several weeks to a year in residency.

The Centre supports a number of informal groups of community and university members who come together to explore and bring visibility to a specific issue through events and research. CFGS research and public engagement build upon our researchers' expertise in four core themes:

Governance

Research engaged with social problems related to large scale political and environmental changes including themes around decolonization and reconciliation, globalization, mass migration, economic exploitation, and new forms of community governance institutions.

CORE THEMES

Research oriented toward governance understood both in institutional and informal terms, including forms of governance not usually associated with the nation-state or other conventional political institutions and community processes where the local and global are tightly interwoven.

Social and Ecological Justice

Culture and Identity

Research focused on changes in ethnic, religious and national cultures in a globalizing world and the challenges and opportunities posed by social and cultural forms spawned by new individual and collective identities.

Environmental Challenges

Research concerned with increasingly critical global environmental crises such as climate change, pandemics, and energy and water scarcity.
