


#### WHO ARE WE?

We regulate the practice of engineering and geoscience.

We set and maintain high standards of practice for these professions.

We ensure applicants have met academic and experience requirements before they can practice.

We ensure public safety and confidence in the geoscience/engineering profession.



#### PROFESSIONAL GOVERNANCE ACT

- The PGA establishes a consolidated framework for professional regulators in the natural and built environment.
- Improves public safety and confidence in the geoscience/engineering profession.
- Requirements to maintain professional registration:
  - Updated Code of Ethics
  - Mandatory Continuing Education
  - Firm Regulation

#### **AS A STUDENT, YOU:**

Have access to networking events to help your career.

Are eligible for scholarships and Student Team Funding.

Can access the same resources as professional registrants.

#### GEOSCIENTIST-IN-TRAINING

#### AS A GIT, YOU:

Require supervision by a professional geoscientist.

Demonstrate academic qualification and professional intent.

Have access to registrant-only program, courses and services

## PROFESSIONAL GEOSCIENTIST

AS A P.GEO., YOU:

Abide by the Code of Ethics.

Take full responsibility for your work (and others)

Are allowed to call yourself a professional geoscientist.

### TYPICAL REGISTRANT TIMELINE

-Graduation--->

#### Student Program

- Undergraduate or master's student
- Has access to member resources, scholarships, team funding

#### Geoscientist-in-Training (GIT)

- Has graduated an undergraduate geoscience program
- Has been granted GIT status (Must apply)

#### Work Experience \_ (at least 4 years)




### Professional Geoscientist (P.Geo.)

- Has completed at least four years of work experience and other requirements
- Licensed to practice Geoscience in BC







## Geoscientist-in-Training (GIT)



#### **ACADEMIC REQUIREMENTS**

#### Applicants must have:

- Graduated from a 4-year bachelor's degree in applied science, geoscience, engineering, science or technology.
- No more than 9 missing topics from the geoscience <u>Self-Evaluation</u> <u>Checklist</u> for the discipline of application.
- Application Disciplines:

Geology

Environmental Geoscience

Geophysics




## HOW TO APPLY FOR GIT

The following are required:

Transcripts (sent directly from institution)

Course descriptions (only for non-BC institutions)

**Self-Evaluation Checklist** 



#### PLANNING YOUR COURSES

During undergraduate program, it is recommended that you cover off as many of the course requirements as possible.

If you have not already done so, please refer to the <u>Self-Evaluation</u> <u>Checklist</u> for your university and specialization.

The checklists will allow you to track your progress and monitor whether you have all the required topics to be considered academically qualified upon graduation.



#### **MISSING TOPICS**

An academic assessment will determine whether you have adequately completed the topic requirements outlined for the discipline you are applying for.

It may be determined that you are deficient in certain topics on the checklist. If this is the case, you will be notified which topics you do not have coverage for.

Topics identified as missing will need to be satisfied either by taking an approved course equivalent or by challenging examinations.




### **EQUIVALENT COURSES**

It is possible to complete courses you do not have coverage of if:

The course is an approved course already listed on an institution's checklist

The course is approved by our Geoscience Subcommittee (Course code and description would need to be provided)

\* Note that some courses can be online and from different institutions



### **EXAMINATIONS**

#### **Exam sessions are held biannually**

- All exams are self-study (you are told the recommended textbook and provided with any supplementary study material)
- Exams are 3 hours in length and can be open or closed book
- Two exam sessions per year May-July (Spring/Summer) and October-December (Fall)
- Exams are computer-based and held virtually



#### **COVID-19 MEASURES**

- Interim grading arrangements
  - Until further notice, academic credentials that are awarded since May/June 2020 will be accepted as long as failures in required courses have been made up by a pass or credit.
- Field Techniques alternatives due to pandemic
  - Pandemic impacted ability to engage in field work outside of classroom
  - May be able to use work experience in lieu (equivalent to 12 days)
  - Guidance available (see link)



# Competency-Based Assessment

Gaining Experience Towards Your P.Geo.



#### COMPETENCY-BASED ASSESSMENT

- Experience assessment is required for P.Geo. Registration (not required to become a GIT)
- Demonstrate <u>29</u> Work Experience Competencies required for registration using <u>Competency</u> <u>Assessment System.</u>
- Requires validation from individuals who have direct, personal and professional knowledge of the applicant and the examples they have been asked to validate.
- Applicants are asked to assess their level of competency for each competency provided on a six-point rating scale (0-5).

#### COMPETENCY-BASED ASSESSMENT

- If you are a GIT, you can gain access to the Competency Assessment System and can save examples as you gain experience over the 4+ years
  - Helps you keep track of your experience progress and plan ahead for your career
  - Allows you to get referee/validator feedback earlier (especially useful if you change employers)
  - Makes it easier to discuss with your supervisor/employer the professional skills and knowledge that you need

## PRE-GRADUATE/POST-GRADUATE EXPERIENCE

- Up to a maximum of 1-year of pre-graduation or co-op experience may be accepted if it is supervised by the appropriate professional and if it otherwise satisfies all experience criteria detailed by Engineers and Geoscientists BC.
- Applicants with post-graduate degrees may be given credit for geoscience experience gained as part of their post-graduate studies. Credit may vary depending on review (typically up to 1-year for Master's (thesis-based programs) or up to 2 years for PhD programs.



#### LAW AND ETHICS

- Prior to professional registration, applicants must complete:
  - The <u>Professional Practice Examination</u>, and
  - the <u>Professional Engineering and Geoscience Practice in BC Online</u> Seminar.
  - You can complete the exam and online seminar while you are a GIT
