**Course Content:** theories of aggregate economic behaviour; the determination of national income and employment, consumption, investment, inflation, growth and fluctuations, economic policy.

The course provides further insights into standard macroeconomic theories and associated applications. It provides a foundation upon which we can analyse past and current macroeconomic issues and apply macroeconomic theories to real world events. We will cover modern theories of aggregate economic behaviour, the determination of national income and employment, consumption, investment, inflation, and growth. The course includes some applications of economic policy problems related to unemployment, aggregate fluctuations, taxation and balance of payments disequilibria. Covering these key macroeconomic concepts will allow us to understand and analyze macroeconomic issues such as economic growth and living standards, inflation, recessions, fiscal and monetary policies, exchange rates, and employment. We take various approaches to the study of macroeconomics and explore a range of models showcasing the wide range of ways of thinking about macroeconomics. We will also emphasize the idea that macroeconomics is mainly a broader perspective on economic phenomena, and the type of questions that are posed. We will look at the economy as a whole (though, the ‘micro’ aspects are important). We will address the following questions: Why are some Countries rich while others are poor? What determines interest rates? How does the Bank of Canada influence the economy? How should Governments intervene when the unemployment rate increases?

**Learning Outcomes:** students will be able to:

- Work with key National Income accounting principles.
- Apply critical thinking to interpret aggregate economic phenomena.
- Sharpen analytical skills by applying simple mathematical tools (algebra and multivariate calculus) to analyze macroeconomic models/
- Manipulate macroeconomic (general equilibrium) models of economic growth and aggregate fluctuations to study the desirability of government intervention.
- Apply both graphical and analytical methods to assess the potential benefits and pitfalls of fiscal and monetary policy.

- Use an economic approach to analyze current events and complex macroeconomic issues.
- Develop a critical understanding of the main paradigms in Macroeconomics.

**Course Prerequisites:** ECON 103, 103C or 180; ECON 104; MATH 100, 102 or 109.

**Minimum Grade Requirement:** ECON 204 has a C as minimum program requirement (for FME, BA and BSc students listed. Students pursuing an Honours degree should consult the academic calendar).

**Assignments (best 3 of 4): 30%** There will be four assignments throughout the course with the *best three* counted. Students will have one week to complete an assignment. Each assignment is worth 10% of the total grade. The main goal of assignments is to allow students in-depth understanding and implementation of the material and knowledge obtained from the lectures and to prepare students for exams and future courses.

*Late Assignments:* Assignments are due in class at 12:30 p.m. on the due date. Out of respect for those students who do submit assignments on time, **late assignments will not be accepted** unless prior arrangement (at least 48h prior to the deadline) has been made with the instructor. Given that *only the best three* assignments will count towards the final grade, if a student misses an assignment due to medical reasons or exceptional circumstances, and can provide documentation, this assignment will be automatically dropped. Please use [this](#) form to ask for an in-course academic concession.

**Midterm Exams: 40%** There will be two 60-minute midterm on **Jan. 31, 2025**, and on **March 10, 2025**. Make-up exams for midterms will not be given and midterms cannot be deferred (i.e., made up after the course has ended). If a student misses *one* midterm due to illness or family affliction, the weight of the missed exam will be shifted to the final exam. In the event that a student misses a *second* exam due to illness or family affliction, please consult the [Academic Concessions](#) portion of the Registrar's website to determine whether a late drop or a withdrawal under extenuating circumstances is appropriate. If a student misses a midterm and a final exam, only the final exam can be deferred by filling a [request for a deferral](#).

**Final Exam: 20%** The final examination will be a comprehensive 3-hour exam. It will be scheduled by the Registrar's Office and a timetable will be posted once available. Please wait until the final examination timetable is available before making any plans to leave Victoria.

**Quizzes and Participation Exercises (best 10 of 11): 10%** There will be 11 in-class quizzes or weekly participation exercises (completed via Brightspace). There will only be one per week, meaning, on a weekly basis, students will receive a quiz **or** a participation exercise, not both. Each quiz or participation exercise is worth 1% of the final grade. Students are expected to attend every lecture, read the textbook and class materials and these assessments are to ensure students are keeping up with the course material. Quizzes will be unannounced and 10-15 minutes long. Participation exercises will be posted by Wednesday and must be completed on a Discussion Board on Brightspace by Friday 4 p.m., that week. Given that only the best 10 quizzes or participation exercises will count towards the final grade, if a student misses a quiz or a participation exercise, it will be automatically dropped. No make-ups will be given for quizzes or participation exercises.

**Essential Course Components: All** exams are essential course requirements, meaning, they must be attempted in order to pass the course. Failure to complete the final exam will result in a grade of 'N' regardless of the cumulative percentage on the course. N is a failing grade and factors into GPA as a value of 0.

**Appealing Grades:** Students who have questions or concerns regarding a grade for any of the assessments should notify the instructor as soon as possible. **All concerns should be addressed during office hours** (please see email policy), with specific questions and formal arguments (i.e., no "why did I get this grade?" rather: "I believe there is an error in the grading because after further investigation I have found that XYZ...") Any concerns must be dealt with **within one week** after the grade was returned, otherwise, **the grade is final**.

**Ensuring Progress and Learning:** Regularly revising lecture notes, trying and practicing problem sets and exercises will be the most effective way to develop the skills needed to succeed in this class. When doing exercises, I strongly encourage students to identify and clearly define core concepts as well as denote each of the steps taken when performing operations to answer a question. This will help clarify the steps involved in a solution and will provide the basis of preparing for assessments as students will need to show their work.

Similarly, please know that I will always be happy to provide additional support during office hours. I strongly encourage students to come to office hours to seek additional help, especially if struggling with a particular subject. While I will not provide the solutions directly, I will help students understand the concepts so that they can arrive at the answers or understanding independently.

**Missing Assessments:** to reiterate, assessment components during the term have built in flexibility for all students. Students can miss one assignment and one quiz/participation exercise without losing any weight on course components rendering the need for in-course concessions via special arrangements unnecessary.

Should students encounter a situation where they miss the midterm or cannot submit an assignment at its due date, they may qualify for an academic concession (as outlined above). Students are required to indicate the specific grounds on which they are requesting an academic concession and to provide a justification outlining the impact of the circumstances on their ability to complete course requirements. Please use [this](#) form to ask for an in-course academic concessions. In case you miss the final exam, fill in a [request for a deferral](#). Students are advised not to make work or travel plans until after the examination timetable has been finalized. Students who wish to finalize their travel plans at an earlier date should book flights that depart after the end of the examination period.
