## **ECONOMICS 346 (CRN 11115):**

Applied Econometrics II

### **OBJECTIVES:**

This course provides an extension of the basic practice of econometric analysis. We will focus on the application of econometric methods to practical data analysis problems, with emphasis on gaining an intuitive understanding of econometric analysis, the interpretation of empirical evidence and on developing practical experience applying these principles through the use of a common statistical package (Stata). Topics will include hypothesis testing, panel data, time series, causality, as well as econometric methods applied to a range of empirical problems.

#### TEXTBOOK

The primary textbook for this course is "Introductory Econometrics: A Modern Approach," (eighth Edition) by J. Wooldridge. Earlier additions will suffice but page numbers may differ. In addition, journal articles will be used to supplement the text.

### **EVALUATION:**

Evaluation in this course will consist of lab participation, **four** lab assignments, **one** inclass exam, and a comprehensive final exam. Exams will be held according to the exam schedule listed below. The determination of your final grade for the course will be based on your participation in weekly labs (accounting for **10%** of your final grade), lab assignments (equally weighted accounting for **20%**), the midterm accounting for **30%**, and the remaining **40%** will be allocated to the final exam.
