# Overview:

The <u>BRAIN Lab</u> and the <u>Rush Slow Lab</u> at the University of Victoria invite applications for a Postdoctoral Fellow (PDF) position in the Department of Psychology. This position offers a unique opportunity for a highly motivated researcher to conduct novel clinically relevant research in the areas of mobile health, cognition, and neuropsychology. The PDF will also be integrated into the <u>Age-Well EPIC (Early Professionals, Inspired Careers)</u> training and mentorship <u>program</u> for Highly Qualified Personnel. The appointment is currently funded for 1 year, with the possibility of extension via successful application for external post-doctoral funding (e.g., CIHR Fellowship, etc.). The PDF will have access to UVic's and BRAIN Lab resources, including PDF office space on campus, the PDF will provide direct support to, and collaborate with, Drs. Theone Paterson & Jonathan Rush on grant-funded research studies investigating the potential utility of mobile health applications and relationships between physical health, health behaviours, psychological wellbeing, and cognitive functioning across the lifespan.

#### **Key Responsibilities:**

- Conduct independent research supporting BRAIN Lab and Rush Slow Lab research initiatives.
- Develop and submit grant proposals to secure external funding.
- Collaborate with faculty members, research staff, graduate students, and other stakeholders.
- Publish research findings in peer-reviewed journals and present at conferences.
- Contribute to the academic community through teaching, mentoring, and/or outreach activities.
- Assist in the preparation of reports and documentation as required.

### **Qualifications:**

- The research interests of the PDF are expected to be a good fit with the above context.
- A PhD in health psychology, cognitive psychology, neuropsychology, clinical neuropsychology, or a closely related field, is required by the start date (see eligibility below for additional information).
- Preferred qualifications include research experience related to cognitive aging and cognitive decline, neurological disorders, and/or mobile health research.
- A strong background in statistics and longitudinal data analysis, including familiarity with R, and/or other relevant software (SPSS and/or MPlus) is required.
- Ability to work effectively with a diverse group of community members, staff, faculty, and technicians

  - o be integrated into the Age-Well training network for Highly Qualified Personnel (HQP)
  - o develop skill in grant writing,
  - o develop skill in and pursue undergraduate teaching (if desired),
