Achieve: The learning platform that accompanies our textbook provides interesting and instructive videos, exercises and examples. It is also a highly efficient way to memorize and recall relevant definitions, statistics and theories. As an incentive to study effectively using this platform, 10% of the overall course grade is based upon the successful completion of the assigned activities and self-quizzes on Achieve. What a deal – get easy points for studying efficiently using Achieve and your scores on the tests will likely be higher too!

Course Description and Learning Outcomes: This course will introduce you to the field of Clinical Psychology, the settings in which clinical psychologists practice, and major aspects of the profession including assessment, diagnosis, case formulation, and therapeutic intervention approaches for various populations. The scientific basis of clinical psychology will be emphasized alongside historical and current trends in clinical practice. You will also learn about the necessary requirements to obtain education and training to become a clinical psychologist. Note: completing this course *does not* give you the qualifications to become a psychologist, conduct psychological therapy or assessment, or provide diagnoses. Many years of post-graduate study and supervised practice are required to provide these health care services.

After completing this course, you will be able to:

- 1. Describe various mental-health professions and differentiate the role of clinical psychologists in mental health.
- 2. Understand the education and training needed to be recognized as a clinical psychologist.
- 3. Describe the scientist-practitioner model, the biopsychosocial approach to mental health and the evolution of evidence-based assessment & intervention in clinical psychology.
- 4. Identify appropriate assessment, intervention, and prevention approaches for various populations (child vs. adult), demographics, and referral requests.
- 5. Demonstrate an understanding of ethical principles/issues in research and clinical practice with special attention to empathy and unconditional positive regard.
- 6. Understand the importance of diversity in clinical science and practice.
- 7. Detail the academic and professional requirements and career trajectory of clinical psychologists (including education paths, career settings, subspecialities).
- 8. Evaluate which of the many mental health professions may be a good fit personally.

Learning Format: Class meets three times per week in-person synchronously. During our meetings, you can expect a mixture of lecture, videos, group discussions and activities aimed to improve your understanding of key course concepts. All of these in-class activities are designed to help you to consolidate information, apply key concepts, clarify misunderstandings and rehearse material to promote learning. You are expected to attend class and <u>read the textbook prior to class</u>. Lectures address some of the core textbook content but will also expand beyond the material in the textbook. We will also use class time for questions and group discussions. If you are not feeling well, you are encouraged to stay home. I will make all slides available on our Brightspace page and will try to post them shortly before class.

Grading: This course requires attendance, preparation for each class and active participation during class. Final grades will be calculated based on the following specific elements:

*Core course assessment requirement. Failure to complete one or more of these elements will result in a grade of "N" regardless of the cumulative percentage of all other elements of the course. N is a failing grade and factors into GPA as a value of 0. Consequently, students can only request deferrals for the completion of required course components and not for non-essential course components.

Clinical reflections (10%): These assignments require you to think critically and respond to a topic related to course material that week. You will be asked to give short reflections on Brightspace most weeks due at 9:00 pm on the assigned date. Late submissions will not count toward your mark. You can skip 2 reflections and still receive full marks as your lowest two scores will be dropped. Whether students have CAL accommodations or not, this allows all students to be in charge of their own scheduling, so please do not request additional late assignment dates. Credit will be given for on-time submission, thoughtful reflection on the classroom activities and a clear understanding of the assigned reading material. These clinical reflections will be assigned during random classes approximately 7 times throughout the semester. The grade for these discussions will be based on the highest 5 submitted reflections, thus NO late/make-up submissions will be accepted for any reason.

Achieve (10%): Regular assignments will be posted in Achieve. This is an efficient way to learn and memorize new information. Most students will earn 90% or higher in Achieve, so this is an easy way to gain points towards your overall grade. Students are welcome to complete these short assignments on or before the scheduled due dates. As there is a 72-hour grace period built into these assignments for students who have accommodations (and for students who may be away for sanctioned sporting or academic events or just choose to take a day or two off from Achieve), NO late/make-up assignments will be accepted for any reason.

Clinical Podcast (20%): This assignment has two parts. First, you will create a 10 to 12-minute podcast that examines one of the topics from the course in more detail. You will upload your podcast on Brightspace by November 13 @ 9:00pm. Second, when all the podcasts are compiled, you will then listen to two of your classmate's podcasts and write a brief 1-page reflection of what you learned from their podcasts (to be submitted by November 27 @ 9:00pm. See grading rubric on Brightspace for more information about the assignment. Please contact the teaching assistant if you have any concerns, questions, or limitations that might affect this assignment.

Please review in full the Department of Psychology's Important Course Policy Information on Brightspace. The use of a generative artificial intelligence (AI) is strictly prohibited in any submitted work. The Department reserves the right to use AI detectors.

Tests (15% each totalling 60% of overall grade): Four tests will be given that cover both the assigned readings and the lectures/class discussions. Tests will include multiple-choice questions and short written answers. The final test will include a relatively small number of cumulative questions covering the entire semester.

Missed tests and Assignments: It is your responsibility to attend class and tests as scheduled. Students who miss an in-class test or the final project assignment will receive a mark of zero unless they have a case of documented illness, accident or a family emergency.

If you miss one test due to illness, accident, or family emergency (note: it is bad form to invent illnesses suffered by a grandparent or a pet garter snake), you should notify me by email as soon as possible (generally within 24 hours of the emergency situation). Your lowest completed test score will substitute for the missed test when final grades are calculated. A substitution score will NOT be made if a student doesn't provide timely email notification as described above. Make-up tests will NOT be given. Students must complete a minimum of 3 tests to pass the course.

Failure to complete one or more of elements A, B, C, E will result in a grade of "N" regardless of the cumulative percentage of all other elements of the course. N is a failing grade and factors into GPA as a value of 0. In

I expect that all work submitted for this course will be your own. Since writing, analytical, and critical thinking skills are part of the learning outcomes of this course, all assignments should be prepared by the student. Specifically, this course forbids the use of ChatGPT or any other generative artificial intelligence (AI) tools at all stages of the work process, including preliminary ones. Use of ChatGPT (or other similar tools or software that generate suggested text) or editing services is not allowed in this class for any part of a graded assignment, including generation of ideas, writing of text, substantive editing, or rewriting your own work. Violations of this policy will be considered academic misconduct. Violations could result in failure of the assignment. Different classes at UVic may implement different AI policies, and it is the student's responsibility to conform to expectations for each course.

These measures will range from a zero on the test or assignment or a failing grade for the course, probation within a program to temporary or even permanent suspension from the University.

Prerequisites

Students who remain in courses for which they do not have the prerequisites do so at their own risk. Students who complete courses without prerequisites <u>ARE NOT</u> exempt from having to complete the prerequisite course(s) if such courses are required for the degree program.

Program Requirements

Registration Status

Students are responsible for verifying their registration status. Registration status may be verified using My Page, View Schedule. Course adds and drops will not be processed after the <u>deadlines</u> set out in the current UVic Calendar.

Students who do not attend classes must not assume that they have been dropped from a course by an academic unit or an instructor. Courses that are not formally dropped will be given a failing grade, students may be required to withdraw and will be required to pay the tuition fee for the course.

Request for Academic Concessions

Students can apply for <u>academic concessions</u> if their course requirements are affected by (i) unexpected and/or unavoidable circumstances (e.g., illness, family affliction, etc.), or (ii) conflicting responsibilities (e.g., service in the armed forces or first responder, representing the university).

- Request an in-course extension
 If you require more time to complete a course requirement or miss a test or midterm exam, then you will need to complete the "In-Course Extension Form" and submit it directly to your course instructor. All course requirements must be completed prior to the submission of final grades.
- What to do if you miss the final exam scheduled during the formal exam period Apply at Records Services for a "Request for Academic Concession", normally within 10 working days of the date of the exam. Records Services will forward the form to the instructor. If the concession is granted, the instructor will determine how to deal with the situation (for example, a deferred exam). Where a concession is not applied for or where such application is denied, an N grade will be entered on the student's academic
- What to do if you require additional time to complete course requirements beyond the normal term. Apply at Records Services for a "Request for Academic Concession", normally within 10 working days of the end of the course. Records Services will forward the form to the instructor. If the concession is granted, the instructor will determine how to deal with the situation. Where a concession is not applied for or where such application is denied, an N grade will be entered on the student's academic record if the missing work has been deemed required. Note, only required course components may be deferred.
