SUGGESTED TEXT: Child Psychpathology 8th Edition by Mash, Wolfe, Williams

PURPOSE: The purpose of this course is to introduce concepts, theory, and research findings central to the study of developmental psychopathology. Specifically the course will focus on reviewing the aetiology, classification, and treatment of number of disorders that present in children and adolescents (such as depression, anxiety, conduct disorder, and autism).

The pre-requisites for this course are Psychology 201 and 260. Those who complete courses without prerequisites are not exempt from having to complete the prerequisite course(s) at some later date if such courses are required for the degree program. Students are responsible for checking their registration status before the end of the add period.

Students who remain in this course who do not have these prerequisites do so at their own peril and are not exempt from having to complete the prerequisite courses if required for the degree program. Students are responsible for checking their registration status before the end of the add period. The Add/Drop dates are: 100% fee reduction deadline is January 18th, 2026; 50% fee reduction deadline is February 8th, 2026; last day to drop February 28th, 2026.

EVALUATION:

TWO SHORT ASSIGNMENTS - ONE FORMAL (APA# 7) AND ONE INFORMAL

A. Formal Discussion Paper (10%): This is a written discussion paper based on several topics given, due in class on the dates indicated below. Each assignment will involve preparing a short discussion paper (maximum = FIVE single-sided and double-spaced pages) in response to the suggested topics. These papers use APA #7 formatting including title, references, in-text citations, paraphrasing, NO direct quotes.

No late assignments will be accepted. They are due on: January 22, February 5, February 26, March 5, March 19, 2026. (Choose 1 of the 5 dates).

B. Opinion Piece (10%): This does NOT require peer-reviewed research. Write a 2- to 4- page opinion piece on the possible role and influence of social media and current technology (e.g., cell phone, television, smart phones, etc.) on the developing child up to the age of 10. I am looking for the inclusion of personal opinion based on your experiences. You will be writing in first person.

Opinion Piece is due: March 2, 2026 (or earlier is fine).

TOTAL VALUE: 20%

1. Examinations: There will be **THREE** short answer examinations (E#1, E#2 ARE 20% each, E#3 is 15%) covering information presented in class. These are completed in class.

TOTAL VALUE: 55%

2. In-class Discussions: There will be five in-class assignments/projects (2% each). These will be in the format of Group Discussions. They will be held on January 19, February 23, March 9, March 23, 2026. (These cannot be made up.)

TOTAL VALUE: 10%

3. Major Project: Choose one of the following options.

OPTION A

Major essay due in class on the date indicated below. It will involve preparing a discussion paper (10 single-sided and double-spaced pages) in response to a topic approved by the instructor. No late papers will be accepted. Your topic must be approved by January 29, 2026. Along with this approval request you must submit a minimum of 3 peer-reviewed references relevant to the topic. Without the approval the final paper will NOT be accepted.

Essay is due: March 16, 2026 (or anytime earlier)

TOTAL VALUE: 15%

OPTION B

Oral Presentation Session: Oral presentations concerning pertinent topics in Child and Adolescent Psychological Disorders will be created by groups of students (no more than 3 students). Topics will be approved by the instructor. Dates to be arranged by January 29, 2026. In addition a 5-7 page paper will be submitted to the instructor one week after the presentation (one per group) **OR** you may choose to submit to me ~ 6 summary slides of your topic that will then be posted in Brightspace for class viewing.

TOTAL VALUE: 15%

OPTION C

Journal: Keep a journal reflecting your thoughts regarding Child and Adolescent Psychological Disorders. You are welcome to include articles of interest with a commentary – these may be from a newspaper or any other form of mainstream media as well as your personal experiences. The personal experiences must be related to concepts of development. <u>A minimum of 10 entries is required – one physical page (that's 2 sides typed in double-spacing format). If hand-written then the entries are somewhat longer.</u>

Please do NOT rely on social media, blogs, televisions shows (Netflix, Crave, TEDX talks) for the majority of your ideas.

Journal is due: March 18th, 2026 (or earlier once the 10 entries are completed)

TOTAL VALUE: 15%

Note: Students who have completed the following elements will be considered to have completed the course:

- element a: 3/3 exams (Total Value 55%)
- element b: 1/1 major project (Total Value 15%)

Failure to complete one or more of these elements will result in a grade of "N" regardless of the cumulative percentage of all other elements of the course.

N is a failing grade and factors into GPA as a value of 0. In accordance with the <u>University's policy on academic concessions</u>, "A student who completes all course requirements is not eligible for an academic concession". Consequently, students can only request deferrals for the completion of required course components and not for non-essential course components.

Note: You are responsible for materials in lectures you do not attend. Tests and examinations will contain short-answer questions. The Department of Psychology fully endorses and intends to enforce rigorously the <u>Senate Policy on Academic Integrity</u>. - 1. **Plagiarism**. You must make sure that the work you submit is your work and not someone else's. There are proper procedures for citing the works of others. The student is responsible for being aware of and using these procedures.
