You will have the opportunity to explore the CHILDES database of child language transcripts, to analyze child language data, and to conduct preliminary research on a topic of your own choice.

and for students who are unable to attend class. However, please be forewarned that technical and human errors sometimes result in unsuccessful recordings. I will be away on a study trip from March 8-16. Lectures those classes will be pre-recorded.

Assignments

It is your responsibility to do the assigned readings, and come to classes ready to ask and answer questions. The quizzes are to be done independently; please review and internalize the material discussed in class. You are welcome to discuss your other assignments with classmates, but you must *do your own analysis and write up your work independently, without the assistance of a human coauthor/editor or an AI content generator*. You are asked to prepare a 3-minute presentation on a topic of your choice related to child language acquisition. Please check the topic with me a week ahead of time, identifying at least one published source. Written assignments are to be uploaded to Brightspace unless I agree to another arrangement ahead of time. Under no circumstances can an assignment be submitted electronically to a TA. An assignment will count as received when uploaded to Brightspace, and as late if received after the deadline. A late assignment will automatically lose 10% (i.e., a small percentage of your final grade), plus an additional 10% per full week that it is late. If you have a valid reason for being unable to meet a deadline, you may request an extension before the deadline via an email with “370B” in the subject header; or, at my discretion, the weight of the missed assignment may be shifted to other assignments. The final exam will be in-person during the exam period, and cumulative.

Any request for reviewing a grade must be submitted to me within a week after the assignment is returned. Numerical grades correspond to letter grades as indicated in the [Calendar](#). An N grade (of 49% or less) will be assigned unless you complete at least the following assignments: (i) the oral presentation, (ii) the final draft of the child language project, (iii) 10 quizzes, and (iv) the final exam. Failure to complete one or more of these elements will result in a grade of “N” regardless of the cumulative percentage of all other elements of the course. N is a failing grade and factors into GPA as a value of 0. In accordance with the University’s policy on academic concessions, “A student who completes all course requirements is not eligible for an academic concession”. Consequently, students can only request deferrals for the completion of required course components and not for non-essential course components.

Policy on Academic Integrity including Plagiarism and Cheating

The Department of Psychology fully endorses and intends to enforce rigorously the [Senate Policy on Academic Integrity](#). It is of utmost importance that students who do their work honestly be protected from those who do not. Because this policy is in place to ensure that students carry out and benefit from the learning activities assigned in each course, it is expected that students will cooperate in its implementation.

The offences defined by the policy can be summarized briefly as follows:

1. **Plagiarism.** You must make sure that the work you submit is your work and not someone else's. There are proper procedures for citing the works of others. The student is responsible for being aware of and using these procedures.
2. **Unauthorized Use of an Editor.** The use of an editor is prohibited unless the instructor grants explicit written authorization.
3. **Multiple Submission.** Only under exceptional circumstances may a work submitted to fulfill an academic requirement be used to satisfy another similar requirement. The student is responsible for clarifying this with the instructor(s) involved.
4. **Falsifying Materials Subject to Academic Evaluation.** This includes falsification of data, use of commercially prepared essays, using information from the Internet without proper citation, citing sources from which material is not actually obtained, etc.
5. **Cheating on Assignments, Tests, and Examinations.** You may not copy the work of others in or out of class; you may not give your work to others for the purpose of copying; you may not use unauthorized material or equipment during examinations or tests; and you may not impersonate or allow yourself to be impersonated by another at an examination. The Department of Psychology has a policy of not making old examinations available for study purposes. Therefore, use of old exams without the express written permission of the instructor constitutes cheating by the user, and abetting of cheating by the person who provided the exam.
6. **Aiding Others to Cheat.** It is a violation to help others or attempt to help others to engage in any of the conduct described above.

The use of a generative artificial intelligence (AI) is strictly prohibited in any submitted work (unless expressly endorsed by the instructor as part of an assignment).

Instructors are expected to make every effort to prevent cheating and plagiarism. This may include the assignment of seating for examinations, asking students to move during examinations, requests to see student identification cards, and other measures as appropriate. Instructors also have available to them a variety of tools and procedures to check for Internet and electronic media-based cheating. Where a concession is not applied for or where such application is denied, an N grade will be entered on the student’s academic record.
- **What to do if you require additional time to complete course requirements beyond the normal term.**
Apply at Records Services for a [“Request for Academic Concession”](#), normally within 10 working days of the end of the course. Records Services will forward the form to the instructor. If the concession is granted, the instructor will determine how to deal with the situation. Where a concession is not applied for or where such application is denied, an N grade will be entered on the student’s academic record if the missing work has been deemed required. Note, only required course components may be deferred.
