Textbook: There is no required text book for this intensive 4th year course. The expectations are for attendance in every class as well as ongoing participation in class activities. When appropriate, handouts will be distributed by the instructor. "As per University Policy, students are expected to maintain regular class attendance. Due to the seminar format of this class, students who do not attend at least 80% of classes will receive an 'N' in the class." Attendance will be taken.

Course Description: "Forensic Psychology - Forensic psychology is the interface between psychology and the law, so all psychological services provided for the legal community are forensic psychological services. However, most forensic psychologists provide services which are both clinical and forensic in nature. When a psychologist treats an individual who was emotionally traumatized by an accident, the treatment is clinical in nature ... But, when the psychologist is asked to provide a report for the court, regarding the extent of the trauma, and to assess the psychological damage incurred, then the psychologist is providing forensic services" (Franklin, 2006). Topics covered in this course will include but not be limited to: victimizers and victims, anger management, violence and violent offenders, abuse and sexual offenders, juvenile offenders, male offenders, female offenders, mental health, mental handicap, and dual diagnoses. Crime, deviance, and justice issues will be examined.

Prerequisites

The prerequisites for this course are PSYC 300A and 300B as a co-requisite. Students who remain in courses for which they do not have the prerequisites do so at their own risk. Those who complete courses without prerequisites are not exempt from having to complete the prerequisite course(s) at some later date if such courses are required for the degree program. Students are responsible for checking their registration status before the end of the add period. The Add/Drop dates are: 100% fee reduction deadline is January 19th, 2025; 50% fee reduction deadline is February 9th, 2025; last day for course withdrawal is February 28th, 2025.

Students will be graded on their performance on 3 exams, a number of group assignments, and a presentation.

1. Exams

Knowledge of the presentations and lectures will be assessed through **THREE** exams. Two will be in the format of a take home exam (distributed only IN CLASS on a Monday and due on the subsequent Thursday). This is an individual project: the final version is due as a hard copy at the beginning of assigned Thursday class. The final in-class exam will include short answer/essay questions based upon issues discussed in class

TOTAL VALUE: 65%

2. Round Tables

Throughout the term each student will be required to complete 10 assigned in-class/ out-of-class summaries of key points raised, addressing salient facts and controversies (1.5% each). This will begin WEEK #2 of lecture and thus be held in the week of January 13, 20, 27, February 3, 10, 24, March 3, 10, 17, 24, 2025. There is no outside class preparation for these assignments. If missed, these cannot be made up.

TOTAL VALUE: 15%

3. Presentation

Using case studies is an informative tool for understanding processes in development, human psychology, actions and behaviours. Small groups will present a case study to the class. A week before the presentation you will supply content of the case study as well as questions about the case that will guide your discussion with the rest of the class. These will be submitted to the instructor for distribution to the class. A week following your presentation you will submit a paper summarizing the case but with a focus on key points raised in the presentation and ideas for improvements, expansions, elaborations for a hypothetical representation (5 to 7 pages in length). You will have the entire class for your presentation and class discussion. Dates for the presentations will be finalized within the first three weeks of classes. These presentations will be held throughout the term. (no more than 3 students per group but there may be less / or done individually)

Note:

Students who have completed the following elements will be considered to have completed the course:

Failure to complete one or more of these elements will result in a grade of "N" regardless of the cumulative percentage of all other elements of the course.

N is a failing grade and factors into GPA as a value of 0. In accordance with

the <u>University's policy on academic concessions</u>, "A student who completes all course requirements is not eligible for an academic concession". Consequently, students can only request deferrals for the completion of required course components and not for non-essential course components.

POLICY ON MISSED EXAMS:

You are responsible for attending midterms and final exams as scheduled. If you miss a midterm due to an unexpected or unavoidable circumstance (e.g., illness, accident, or family affliction), you must send Dr. Bain as soon as possible indicating that you have missed the midterm, and the reason for it within your comfort level of disclosure. You do not need to provide any formal documentation if the reason is for an unexpected or unavoidable circumstance. If you are missing a midterm due to conflicting responsibility (e.g., representing the university at a academic, artistic, or sporting event; service in the armed forces or emergency services), then documentation is required prior to the exam or midterm. If the reason for missing the exam is deemed acceptable, then a grade for the missing midterm will be generated by proportionally weighting the performance on the other midterm and the final exam.

Failure to contact the instructor will mean a grade of 0 will be assigned to the missing midterm. **No make-up exams will be scheduled**.

Final Exam: If you are unable to attend the final exam you must apply to Records Services for a "Request for Academic Concession" (RAC), typically within 10 working days of the exam date. If an academic concession is granted for the final exam, an alternative date to write the make up exam MUST be arranged with the instructor. **Any student who does not take the final exam will receive an "N" in this course.**

Policy on Academic Integrity including Plagiarism and Cheating

The Department of Psychology fully endorses and intends to enforce rigorously the <u>Senate Policy on Academic Integrity</u>. It is of utmost importance that students who do their work honestly be protected from those who do not. Because this policy is in place to ensure that students carry out and benefit from the learning activities assigned in each course, it is expected that students will cooperate in its implementation.

The offences defined by the policy can be summarized briefly as follows:

- 1. **Plagiarism**. You must make sure that the work you submit is your work and not someone else's. There are proper procedures for citing the works of others. The student is responsible for being aware of and using these procedures.
- 2. **Unauthorized Use of an Editor**. The use of an editor is prohibited unless the instructor grants explicit written authorization.
- 3. **Multiple Submission**. Only under exceptional circumstances may a work submitted to fulfill an academic requirement be used to satisfy another similar requirement. The student is responsible for clarifying this with the instructor(s) involved.
- 4. **Falsifying Materials Subject to Academic Evaluation**. This includes falsification of data, use of commercially prepared essays, using information from the Internet without proper citation, citing sources from which material is not actually obtained, etc.
- 5. Cheating on Assignments, Tests, and Examinations. You may not copy the work of others in or out of class; you may not give your work to others for the purpose of copying; you may not use unauthorized material or equipment during examinations or tests; and you may not impersonate or allow yourself to be impersonated by another at an examination. The Department of Psychology has a policy of not making old examinations available for study purposes. Therefore, use of old exams without the express written permission of the instructor constitutes cheating by the user, and abetting of cheating by the person who provided the exam.
- 6. **Aiding Others to Cheat**. It is a violation to help others or attempt to help others to engage in any of the conduct described above.

Where a concession is not applied for or where such application is denied, an N grade will be entered on the student's academic record.
- What to do if you require additional time to complete course requirements beyond the normal term. Apply at Records Services for a "Request for Academic Concession", normally within 10 working days of the end of the course. Records Services will forward the form to the instructor. If the concession is granted, the instructor will determine how to deal with the situation. Note, only required course components may be deferred.
