**Text :** There is no required text book for this intensive 3<sup>rd</sup> year course (although there are reference books available in the library BF724 section). The expectations are for attendance in every class as well as ongoing participation in class activities.

The expected delivery is face-to-face. As suggested above this is an intensive course with daily classes. Please submit all work on time. I will NOT be permitting any extensions and I am also not available to students in the month of August through September 6<sup>th</sup>, 2023.

**Purpose of the course:** Adolescent Development examines a number of issues in the development of youth including the influences of biological (e.g., sexual development), psychological (e.g., the role of stress), and social (e.g. peer relationships) factors. Development may be viewed as change; in adolescence there are variations in biological, cognitive, and social expression over time. Beginning with an examination of traditional ideas regarding adolescence, such as biological theories, learning theories, and sociological theories, a wide selection of topics will be presented that assist in the understanding of the interplay of developmental tasks in adolescence.

**Course prerequisites:** PSYC201 and PSYC243  
Credit will be granted for only one of PSYC 336, PSYC 333A

Students who remain in this course who do not have these prerequisites do so at their own peril and are not exempt from having to complete the prerequisite courses if required for the degree program. **2. Assignment:** There will be **ONE** written assignments (15% each), out of topics given, due in class on one of the dates indicated below. The assignment will involve preparing a short discussion paper (maximum = **FIVE** double-spaced pages) in response to topics offered by the instructor. No late papers will be accepted.

Assignments are due: **July 10, 17, 24, 2023 – CHOOSE 1 OF THESE DATES.**

**3. Examinations:** There will be three short answer examinations covering information presented in class.

Examinations: **July 14, 21, 27, 2023**

**TOTAL VALUE: 55%**

**4. Project: Debate/ or Essay only:** Debates concerning pertinent topics in Adolescent Psychology will be created by teams of 4 students **BASED ON A TOPIC OF CONTROVERSY** (e.g., adolescents today have higher levels of narcissism). An essay of 4 pages (approximately) will be submitted by each group within 2 days after the debate. This paper is a reflection of the presentation including offered changes and responses to questions posed in class.

Students may also choose to complete an essay alone. This will be an 8 to 10-page document on a topic approved by the instructor. This essay (APA #7 format) is due July 21, 2023.

Debate dates will be finalized by July 7, 2023.

**TOTAL VALUE: 15%**

**Note:** You are responsible for materials in lectures you do not attend. Tests and examinations will contain both multiple-choice and short-answer questions. Missed examinations with a valid reason will be made up at the earliest convenient time. If you miss a final examination due to illness, accident, or family affliction, you must apply at Record Services for a “Request for Academic Concession” within 10 working days of the exam date. Missed examinations without a valid reason will receive a score of zero. Letter grades will be assigned as follows with scores derived to 3 decimal places.

Failure to complete one or more of these elements will result in a grade of “N” regardless of the cumulative percentage of all other elements of the course. N is a failing grade and factors into GPA as a value of 0.

Consequently, students can only request deferrals for the completion of required course components and not for non-essential course components.

## Policy on Academic Integrity including Plagiarism and Cheating

The Department of Psychology fully endorses and intends to enforce rigorously the [Senate Policy on Academic Integrity](#). It is of utmost importance that students who do their work honestly be protected from those who do not. Because this policy is in place to ensure that students carry out and benefit from the learning activities assigned in each course, it is expected that students will cooperate in its implementation.

The offences defined by the policy can be summarized briefly as follows:

1. **Plagiarism.** You must make sure that the work you submit is your work and not someone else's. There are proper procedures for citing the works of others. The student is responsible for being aware of and using these procedures.
2. **Unauthorized Use of an Editor.** The use of an editor is prohibited unless the instructor grants explicit written authorization.
3. **Multiple Submission.** Only under exceptional circumstances may a work submitted to fulfill an academic requirement be used to satisfy another similar requirement. The student is responsible for clarifying this with the instructor(s) involved.
4. **Falsifying Materials Subject to Academic Evaluation.** This includes falsification of data, use of commercially prepared essays, using information from the Internet without proper citation, citing sources from which material is not actually obtained, etc.
5. **Cheating on Assignments, Tests, and Examinations.** You may not copy the work of others in or out of class; you may not give your work to others for the purpose of copying; you may not use unauthorized material or equipment during examinations or tests; and you may not impersonate or allow yourself to be impersonated by another at an examination. The Department of Psychology has a policy of not making old examinations available for study purposes. Therefore, use of old exams without the express written permission of the instructor constitutes cheating by the user, and abetting of cheating by the person who provided the exam.
6. **Aiding Others to Cheat.** It is a violation to help others or attempt to help others to engage in any of the conduct described above.

**The use of a generative artificial intelligence (AI) is strictly prohibited** in any submitted work (unless expressly endorsed by the instructor as part of an assignment). The Department reserves the right to use AI detectors.

Instructors are expected to make every effort to prevent cheating and plagiarism. - **What to do if you miss the final exam scheduled during the formal exam period**

If the concession is granted, the instructor will determine how to deal with the situation (for example, a deferred exam). Where a concession is not applied for or where such application is denied, an N grade will be entered on the student’s academic record.
- **What to do if you miss an exam other than one scheduled during the formal exam period**  
Do not apply at Records Services for a “Request for Academic Concession”. Instead, contact your course instructor (or designated teaching assistant) to let them know why you missed the exam. Medical documentation is not required.
- **What to do if you require additional time to complete course requirements**  
Apply at Records Services for a “Request for Academic Concession”, normally within 10 working days of the end of the course. Records Services will forward the form to the instructor. If the concession is granted, the instructor will determine how to deal with the situation. Where a concession is not applied for or where such application is denied, an N grade will be entered on the student’s academic record if the missing work has been deemed required. Note, only required course components may be deferred.
