Electives can include additional music or Fine Arts courses: MUS102A, MUS102B, MUS121, MUS123, MUS171A, and MUS171B are recommended in Year 1 or 2 as preparation for 200-level and higher musicology and theory topics. MUS105, MUS131, and MUS207 introduce composition, music education and music technology, respectively. MUS180A-F and MUS181 are opportunities for playing or singing in **ensembles**. Lessons may be available on request to the School of Music.

- Music courses and electives are offered during September to April.
- Courses for electives are also offered summers (May to August, various dates; may include online synchronous or asynchronous options).
- Credit for co-requisites and electives can be applied to another declared program, such as a minor or double major, or to a concurrent credential, such as a certificate.
- Full-time students: Complete at least 12 units by April 30 of Year 1 to gain **second year standing**.

FACULTY & UNIVERSITY REQUIREMENTS

In addition to the listed courses, you must satisfy all **requirements for the Faculty of Fine Arts**, as well as complete at least 30 of the minimum 60 required units at UVic. Within these 60 units, **21 units must be upper-level (300/400-level)** courses, and 18 of those 21 units must be taken at UVic.

ACADEMIC WRITING REQUIREMENT

If you've not already satisfied UVic's **Academic Writing Requirement (AWR)**, you'll need to complete one of ATWP 110, ATWP 135, ENSH 101, ENSH 102, ENSH103, or another approved course. Your program may also list one or more of these courses as mandatory requirements. See above.
