Kevin Hall, President and Vice-Chancellor presented his report. On behalf of the university's executive team, he thanked the Board members who are finishing their terms.

2023 Times Higher Education Impact Rankings

UVic was ranked 9th in the world overall ad 3rd in Canada for university contributions to the United Nations' Sustainable Development Goals (SDG), out of nearly 1,600 institutions. UVic placed third in the world and first in Canada for SDG 13: Climate Action and fourth in the world for SDG 11: Sustainable Cities and Communities.

Spring Convocation

K. Hall spoke of the honour of presiding with Chancellor Buller over nine convocation ceremonies as well as three Indigenous student recognition ceremonies.

As part of the ceremonies, two honorary degrees were awarded. Ann Livingston received the Honorary Doctor of Laws and Zainub Verjee received the Honorary Doctor of Fine Arts.

President's Chair

K. Hall noted that the President's Chair recognizes and celebrates the university's most outstanding scholars and is the highest honour UVic can bestow on a faculty member. He extended his congratulations to Natalie Ban, a marine conservation scientist in UVic's School of Environmental Studies.

- Richard Fox, Department of Pacific and Asian Studies, Faculty of Humanities who has received a Henry Luce Foundation grant for half a million USD to support their Canadian Southeast Asian Studies Initiative.
