6. President's Report

Kevin Hall, President and Vice-Chancellor provided his report.

Convocation

K. Hall noted that on November 12 and 13, he and the Chancellor presided over Fall Convocation and attended the Indigenous Recognition Ceremony for graduating students.

Stocktober

K. Hall stated that the annual fundraising drive for the student food bank was a huge success with more than \$37,000 raised for the UVSS Food Bank and Free Store to help students facing food insecurity. With matching gifts from Island Savings, anonymous donors and Greystar, more than \$50,000 was available for students in need. In addition, over 100 boxes of food and essential items were donated.

Campus Kudos

K. Hall mentioned the upcoming Campus Kudos which celebrates and acknowledges the accomplishments of faculty, staff and students.

Five Days of Action

K. Hall reported that from November 4-8, 2024, the annual Five Days of Action took place. This weeklong event is aimed at amplifying the work groups, units and organizations that are working to create a more diverse, inclusive and equitable campus and community throughout the year.

Vikes Update

The President noted that the women's field hockey team won their sixth-straight U SPORTS national championship banner, while the women's rowing team won their third consecutive Canadian University Rowing Championship title. Women's rowing head coach Jane Gumley earned Canadian University Rowing Female Coach of the Year. The women's rugby team travelled to PEI for the U SPORTS Championship and brought home the national silver medal for the second-straight year. The women's cross-country team finished in third place with bronze medal at the U SPORTS Cross Country Championship, their highest finished since 2011. Coach Hilary Stellingwerff earned the Canada West Female Coach of the Year honours this year as well.

Awards

K. Hall shared some recent awards. He noted that Susan Corner is this year's recipient of the National Academic Advising Association's prestigious Charlie Nutt Global Advising Award for Excellence. Kathryn Mockler (Writing) was named the winner of the City of Victoria Butler Book Prize. Basma Majerbi (Business) was named a Canada Clean50 award winner for 2025. Mark Lewis (Math and Stats) won the 2024 Okubo Prize from the Society for Mathematical Biology and the Japanese Society for Mathematical Biology.

- E. Croft stated this is an annual report on both overall enrolment and breaking out domestic, graduate and international. The university met targets set by Ministry and the Board of Governors.

B. Cant invited E. Croft to provide a summary. She stated that once again, the university met 100% of unmet need in terms of bursary support for students. Some revisions around investments have helped meet the targets. E. Croft thanked Robina Thomas, Vice-President Indigenous for the work to provide Indigenous support awards. She reflected that the total amounts have a very strong impact on individuals needing the aid.

12. Compensation and Review Committee (Paul Ramsey for Christina Clarke)

a. Pay Transparency Report

P. Ramsey introduced Kane Kilbey, Associate Vice-President Human Resources. K. Kilbey provided background on the Pay Transparency Report and thanked the group who compiled the data from approximately 10,000 employees' feedback. He noted the report followed the template from the gender equity provincial group. The results were published on November 1, 2024. K. Kilbey provided a summary of the data outlined in the report.

13. Presentation on University Rankings

P. Ramsey introduced Dane Berry, Associate Director Research Intelligence who provided a presentation on the university rankings. D. Berry highlighted where the university stands in terms of the Times Higher Education Impact Rankings, the QS World University Rankings, and the Shanghai Rankings.

He noted that the THE Impact Rankings evaluates progress against the United Nations' Sustainable Development Goals, using calibrated indicators, across three areas: research, outreach and stewardship.

D. Berry stated that for Maclean's 2005 University Rankings, the University of Victoria ranked 2nd Overall in Comprehensive Universities and outlined results in particular categories.

He concluded by stating that rankings are not the goal, research and operational excellence is the foremost goal.

In response to a question from a member regarding STG rankings and if there is any form of national or international conversation about influencing the ranking in a way that would ensure it reflects UVic at its strengths, D. Berry stated that in some regions that is in effect. In Europe, there is more momentum to influence the ranking bodies while there is less in North America. Universities have limited leverage to affect the rankings. Lisa Kalynchuk, Vice-President Research and Innovation added that when in attendance at ranking events, there is a data master class to show the metrics used and the weighting. They ask for feedback and are willing to listen about changing.

In response to another comment from a member regarding the university's results in reputational surveys, a suggestion was made that there could be a role in External Relations to push reputation built outside of self referential.

C. Horbachewski offered some reflections of where progress in this area could be possible. D. Berry also provided some comments on the work being undertaken at the university to enhance the university's results in reputational surveys related to rankings.

There being no other business, the meeting adjourned at 11:45 a.m.
