Appeals Received

The Senate Committee on Appeals (the "Committee") received ten appeals in 2024/2025.

Non-Academic Misconduct Appeals:

The Committee received one non-academic misconduct appeal in 2024/2025. The appeal involves a decision on a time-limited suspension from the university. This appeal is ongoing.

Academic Appeals

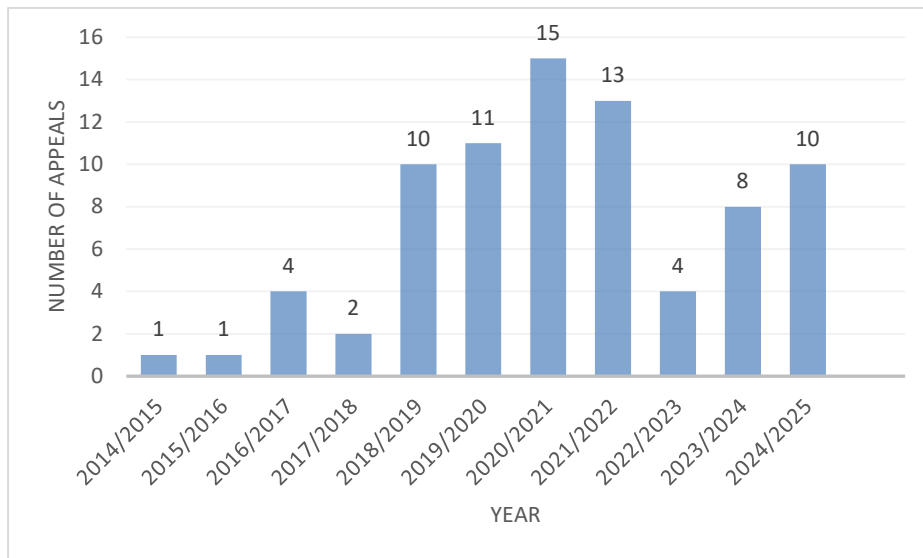
The Committee received eight academic appeals in 2024/2025. One appeal received was a re-opened case based on Section 8 of the Procedural Guidelines. Seven of these appeals are ongoing. Below is a brief description of each of these appeals:

1. Under section 8 of the [Senate Committee on Appeals Procedural Guidelines](#), a request was received to re-open an appeal. This re-opened appeal was dismissed.
2. An appeal involving a student required to withdrawal from the Faculty of Human and Social Development. This appeal is ongoing.
3. An appeal involving a violation of the Policy on Academic Integrity. This appeal was dismissed.
4. An appeal involves a violation of the Policy on Academic Integrity. This appeal is ongoing.
5. An appeal a denial of a student's request for a Withdrawn Under Extenuating Circumstances (WE) Academic Concession. This appeal is ongoing.
6. An appeal involving a decision to deny a student's re-admission to the Faculty of Law. This appeal is ongoing.
7. An appeal involving a decision to deny a student's admission to the Faculty of Law. This appeal is ongoing.
8. An appeal involving a violation of the Policy on Academic Integrity. This appeal is ongoing.
