ii. Establishment of Term ECS-CAPI Chair in Inclusive Science, Technology and Engineering

E. Croft introduced the proposal.

Mina Hoofar, Dean of the Faculty of Engineering and Computer Science, outlined the purpose for the establishment of the ECS-CAPI Chair in Inclusive Science, Technology and Engineering.

In response to questions from Senators, M. Hoofar outlined the work of the Chair with industry partners, the benefit of peer mentoring for students, and the work to focus on women and under-represented groups.

<u>Motion:</u> (E. Croft/M. Hoofar) That Senate approve, and recommend to the Board of Governors that it also approve, the establishment of the ECS-CAPI Chair in Inclusive Science, Technology and Engineering in the Faculty of Engineering and Computer Science and Centre for Asia-Pacific Initiatives for a five-year term, from July 1, 2022 to June 30, 2027.

9. OTHER BUSINESS

a. Academic Important Dates

A. Saab introduced and reviewed the changes to the Academic Important Dates as outlined in the memo.

One Senator noted a desire to implement a university closure for the National Day of Truth and Reconciliation regardless of a provincial decision.

Senators noted the need for improved standards for instructional minimums to consider the impact on multi-section courses and week-long lab blocks. A. Saab agreed that this was an issue to be examined and reflected on the academic timetable to introduce improvement.

Finally, Senators discussed the add/drop date gap.

<u>Motion:</u> (S. Minshall/M. Garcia-Barrera) That Senate approve the Academic Important Dates for the period January 2024 through April 2024 for submission to the January 2023 undergraduate and graduate academic calendar publications.

b. Update on Elections to Senate

A. Saab provided Senate members with an update on the recent resignation of Rustom Bhiladvala, faculty member-at-large, and the subsequent election of Paul Walde as a replacement for January 2023. She also noted that that all the student Senator positions were filled in the recent third call for nominations.

c. Election of Vice-Chair of Senate

S. Klein called for nominations for the position of Vice-Chair of Senate. Alivia Wang nominated Robin Hicks, who accepted the nomination. There being no other nominations, R. Hicks was acclaimed as Vice-Chair.

d. Joint Senate Board Retreat

A. Saab reminded members of Senate of the date for the Joint Senate Board Retreat on November 25, 2022. She briefly outlined the planned agenda, noting that members of Senate will be invited to participate in Indigenous Acumen Training led by Senator Rob Hancock.

There being no other business the meeting was adjourned at 4:23 p.m.

Re: 2021/22 Annual Report

The Terms of Reference for the Senate Committee on Academic Standards define its scope and relationship with Senate and other Senate committees. Each fall term the committee presents an annual report to Senate on its business and proceedings over the previous academic year.

The Senate Committee on Academic Standards met nine times in 2021/22. Meetings occurred September 10, 2021, October 20, 2021, November 4, 2021, December 10, 2021, January 13, 2022, February 11, February 22, 2022, April 12, 2022, and May 22, 2022. During the course of the year, the committee approved the convocation lists of faculties, approved a number of posthumous degrees, made recommendations to Senate, initiated projects in areas of the committee's concern, and received proposals for input from other Senate committees.

Within these areas, the committee considered a number of issues including:

This temporary revision would add grounds to request a WE grade status for any course modality change for the duration of a course. The proposal was approved by Senate at its March 2022 meeting.

Continued Projects in 2021/22

Annual Review of Grading Patterns Report

At its December meeting, reviewed the 2020/21 report. The committee took careful note of grade inflation though the pandemic and need for Deans, Chairs and instructors to make use of the report.

Aegrotat Grade Notation

At its September meeting, the committee began to review the various definitions regarding the university's Aegrotat grade notation.

Academic Integrity Policy

Throughout the academic year, the committee received updates and proposed revisions to sections of the policy.

Provided Feedback from Other Areas:

At its January meeting, the committee provided feedback on the proposed revisions to Policy AC1205: Academic Accommodation and Access for Students with Disabilities.

At its April meeting, the committee learned more about non-credit and for-credit courses within the Division of Continuing Studies.

At its April meeting, the committee reviewed and provided feedback on a proposal on For-Credit Micro-Credentials at UVic.

The Terms of Reference for the Senate Committee on Awards define its scope and relationship with Senate and other Senate committees. Annually in October, the committee presents a report to Senate on its business and proceedings over the previous academic year.

The Senate Committee on Awards met 13 times between July 2021 and June 2022:

The Senate Committee on Awards approved **103** (90) new awards and **74** (62) revised awards for undergraduate and graduate students in 2021-2022.

This report presents the scholarships awarded in the May 2021 to April 2022 academic year. Please note that a report detailing the undergraduate scholarships awarded in the twelve months October 2020 to September 2021 was presented to Senate in November 2021. Historically, this report had reflected an October to September timeframe. All future reports to Senate will represent scholarships awarded during the May to April academic year.

On the May 2021 to April 2022 academic year there were **5,751** (4,896) scholarships awarded to **4,711** (3,925) undergraduate students, with a total value of **\$16,031,568** (\$12,870,136).

NOTE: 2020-2021 figures are shown in parenthesis. Scholarships included in this report were awarded in 2021-2022 on the basis of academic performance in 2020-2021.

UVic aspires to be both nationally and internationally competitive in recruiting and retaining students of the highest caliber. Our ability to offer a more competitive undergraduate scholarship program supports the UVic Strategic Framework vision of attracting, supporting and developing a diverse community of talented students, faculty and staff, as well as being recognized internationally as a university of choice. Through involvement in the Strategic Enrolment Management process, Student Awards and Financial Aid continues to work to better align our student financial aid resources with institutional enrolment goals.

Entrance Scholarship Appeals considered

There were 33 entrance scholarship appeals, of which 13 were granted and 20 were not approved. Of the entrance scholarship appeals, 5 were appealing a renewable scholarship and 28 were appealing a non-renewable scholarship. Of the renewable scholarship appeals, the categories of appeals were as follows: 3 were below the admission average cut-off, 1 was requesting approval to retain the scholarship at a reduced course load and 1 was requesting a scholarship deferral. Of the non-renewable scholarship appeals, the categories of appeals were as follows: 12 were below the admission average cut-off, 13 were requesting approval to retain the scholarship average cut-off, 13 were requesting approval to retain the scholarship and 28 were as follows: 12 were below the admission average cut-off, 13 were requesting approval to retain the scholarship at a reduced course load and 3 were requesting approval to retain the scholarship at a reduced course load and 3 were requesting approval to retain the scholarship at a reduced course load and 3 were requesting approval to retain the scholarship at a reduced course load and 3 were requesting approval to retain the scholarship at a reduced course load and 3 were requesting a scholarship deferral.

In-course Scholarship Appeals considered

There were 80 in-course scholarship appeals, of which 68 were granted and 12 were not approved. Of the in-course scholarship appeals, 68 were appealing to retain a renewable scholarship and 12 were appealing to retain a non-renewable scholarship. Of the renewable scholarship appeals, the categories of appeals were as follows: 62 did not meet the minimum GPA requirement of 7.5 to retain the scholarship, 4 were requesting to retain the scholarship at a reduced course-load and 2 were requesting a scholarship deferral. Of the non-renewable scholarship appeals, the categories of appeals were as follows: 7 were requesting to retain the scholarship at a reduced course-load and 5 were requesting a scholarship deferral.

Scholarship selection sub-committees

In addition to considering new and revised scholarships, awards, medals, prizes and bursaries for recommendation to Senate and making decisions regarding appeals, the Senate Committee on Awards is tasked with selecting the recipients of scholarships offered to students across disciplines.

In 2021-2022 8 sub-committees of 2 to 3 members read 255 applications and selected the recipients and alternates for 8 scholarship programs. Three of the programs offer scholarships to multiple recipients.

ENTRANCE SCHOLARSHIPS

Student Awards and Financial Aid made offers of entrance scholarships to academically outstanding students from Canadian secondary schools, international secondary schools and Canadian colleges and universities. UVic awarded **2,639** (2,625) entrance scholarships (non-renewable) to **2,313** (2,204) students with a value of **\$6,621,747** (\$6,247,932). In addition, **485** (356) students received renewable scholarships (see table below) for a total value of **\$3,113,500** (\$2,240,450). The total of all entrance scholarships and awards from base budget, donor funded and endowed sources is **\$9,735,247** (\$8,488,382).

Appendix 1

Scholarships, fellowships, awards, medals and prizes

Financial aid awarded as scholarships, fellowships, awards, medals and prizes are made available to students primarily on the basis of academic merit. These forms of financial aid have an academic threshold requirement but recipients may also be selected on the basis of additional criteria as specified in the terms of reference. The list of additional criteria includes, but is not limited to, financial need, community service, demonstrated leadership, region, athletic participation, entrepreneurship, ethnicity or gender.

In some cases the academic threshold may be lower than what is generally required for a scholarship. For example, unless otherwise specified, an admission average of 85% or higher is the minimum academic requirement for undergraduate entrance scholarships. The standard for athletic awards is set by U SPORTS, a regulatory organization external to UVic, and varsity student athletes receiving an athletic award in their entering year must have an admission average of at least 80%.

Bursaries

Financial aid in the form of non-repayable bursaries is made available to students on the basis of demonstrated financial need. There may be additional selection criteria specified in the terms of reference, but financial need is the primary selection criteria.

Athletic Awards

Selection of athletic award recipients is made by the Senior Director of Athletics and Recreation in consultation with the Varsity Head Coach and the Director of Varsity Performance Sport. Recipients must meet the eligibility requirements of the governing body for their sport, U SPORTS or the *National Association of Intercollegiate Athletics* (NAIA), who also set the regulations regarding the total amount of financial aid a varsity student athlete can receive per academic year. Varsity student athletes receiving an athletic award in their entering year must have an admission average of at least 80%. In-course recipients must maintain the U SPORTS minimum GPA of 3.0 to receive an athletic award.

Terms for New and Revised Awards

Doreen J. Renton Bursary* (New)

One or more bursaries are awarded to women undergraduate or women graduate students who, at the time of application, are not legally married or living common law.

G. Neil Perry Award in Public Administration* (Revised)

One or more awards will be given to students whose Administration 598 report is judged to be the best. <u>Graduating students are eligible for this award</u>. Approval of the recipient(s) will be made by the Faculty of Graduate Studies Graduate Awards Committee upon the recommendation of the School of Public Administration.

Jacob Kerr Scholarship (Revised)

A scholarship of \$1,000 is awarded to an academically outstanding undergraduate student entering the Department of Computer Science directly from a Canadian secondary school who has demonstrated financial need.

Kathleen B. Tobin Memorial Bursary Award* (Revised)

One or more <u>awards bursaries</u> are awarded <u>given</u> to students entering the final year of the Bachelor of Education Program <u>who have demonstrated financial need and a</u> with demonstrated aptitude in teaching primary students. <u>Approval of the recipients will be made</u> <u>by the Senate Committee on Awards upon the recommendation of the Faculty of Education</u>.

Pacific Coast Swimming Vikes Women's Swim Award* (New)

One or more awards are given to women undergraduate or women graduate students who compete on the Vikes Swim Team. Preference is for students who participate in competition year round. Eligible students must meet all U SPORTS eligibility requirements. Award recipients will be selected on the basis of work ethic, commitment and performance criteria set by the Varsity Head Coach in consultation with the Director of Varsity Performance Sport and the Senior Director of Athletics and Recreation.

Steven P. Starkovich Opportunity Entrance Award (Revised)

One or more awards are given to <u>Canadian-born</u> Indigenous undergraduate students entering the University of Victoria <u>who have demonstrated financial need.</u>

Ted L. McDorman Annual Entrance Scholarship in Law (New)

One or more scholarships are awarded to academically outstanding undergraduate students entering the Faculty of Law, with preference for students either born in Atlantic Canada or who received an undergraduate degree from a university in Atlantic Canada. The four Atlantic provinces are New Brunswick, Newfoundland and Labrador, Nova Scotia and Prince Edward Island.

Approval of the recipients will be made by the Senate Committee on Awards upon recommendation of the Faculty of Law.

Madame Berangere Steel Memorial Scholarship Award* (Revised)

One or more <u>awards are given scholarships are awarded</u> to <u>academically outstanding to</u> <u>undergraduate</u> students <u>who attain the highest grades in FRAN 275 (Writing in French 1)</u> <u>and in the second year French composition courses</u> who are proceeding towards a majors or honours degree in French <u>and Francophone Studies</u>. Approval of the recipients will be made by the Senate Committee on Awards upon the recommendation of the Department of French <u>and Francophone Studies</u>.

Ken Woods Vikes Women's Basketball Award* (New)

One award is given to an undergraduate or graduate woman student who competes on the Vikes Women's Basketball team. Eligible students must meet all U SPORTS eligibility requirements. The award recipient must:

- be an impact player (starting 5th or 6th woman)
- demonstrate leadership, work ethic and a commitment to improving on the court
- be committed to academic excellence, and
- be a positive role model in the community (on or off campus).

The award recipient will be selected by the Varsity Head Coach in consultation with the Director of Varsity Performance Sport and the Senior Director of Athletics and Recreation.

Graeme Jackson Award (Revised)

An award is given to a fourth year undergraduate student in the Peter B. Gustavson School of Business who demonstrates a strong entrepreneurial spirit. The recipient must have completed an international exchange with one of the business school's recognized international exchange partners.

The recipient is selected based on nominations received from fellow students, faculty and/or staff. Nomination letters (maximum 500 words) must include or provide examples of:

- 1. where and when the nominee went on their international exchange;
- 2. how the nominee has made meaningful connections during their time at UVic.

3. how the nominee demonstrates a passion for life in areas such as work experience, community involvement and/or family;

- 4. when the nominee helped to positively impact other students; and
- 5. how the nominee demonstrates a strong entrepreneurial spirit

Applicants must also submit a brief personal statement (max 500 words) that outlines the above nomination criteria. Both the nomination letter and the personal statement must be submitted to the Administrative Director of the Bachelor of Commerce program by May <u>31</u> 15. Graduating students are eligible for this award. Approval of the recipient will be made by the Senate Committee on Awards upon the recommendation of the Gustavson School of Business.

Nominations must be submitted to the Administrative Director of the Bachelor of Commerce program by May 31. Graduating students are eligible for this award. Approval of the recipient will be made by the Senate Committee on Awards upon the recommendation of the Gustavson School of Business.

Pratt-Short Memorial Scholarship* (Revised)

<u>One or more-A</u> scholarship<u>s are</u> is awarded to a <u>academically outstanding undergraduate</u> student<u>s</u> with broad interests <u>continuing in the University of Victoria</u>. completing second year.

Bill Buckwold/Jennifer Richardson Award* (Revised)

An award is given to a BCom or MBA graduating student who has demonstrated a substantial improvement and who has overcome a significant challenge to achieve their educational goal. <u>Applicants must submit a cover letter and resume to the BCom Student</u> <u>Services office (BEC 283) either in person or by email Applications may be obtained from the Peter B. Gustavson School of Business and must be submitted to the Dean's Office by April 30th. If an undergraduate student, selection will be made by the Senate Committee on Awards and if a graduate student, selection will be made by the <u>Faculty of</u> Graduate <u>Admissions and Studies Graduate</u> Awards Committee both upon the recommendation of the Peter B. Gustavson School of Business.</u>

Susan Loven Scholarship (New)

One scholarship of at least \$3,000 is awarded to an academically outstanding PhD student in the School of Nursing, with preference for a student with financial need. If there are no eligible PhD candidates, the scholarship may be awarded to an academically outstanding Masters student in the School of Nursing, with preference for a student with financial need. Approval of the recipient is made by the Faculty of Graduate Studies Graduate Awards Committee upon the recommendation of the School of Nursing.

At its meeting on October 5, 2022, the Senate Committee on Planning considered the proposal to discontinue the Latin American Literary and Cultural Studies program.

Latin American Studies is currently divided into two programs, Latin American Interdisciplinary Studies, and Latin American Literary and Cultural Studies. Historically, Latin American Interdisciplinary Studies has attracted far more students than Latin American Literary and Cultural Studies. The Latin American Literary and Cultural Studies program replicates content already offered in the Spanish program, and is also replicated in the Latin American Interdisciplinary Studies program. It is redundant and competes with the Spanish program. The proposed change would create one single Latin American Interdisciplinary Studies program that is distinct from Spanish and includes all the courses that are currently offered in the Latin American Interdisciplinary Studies program.

The following motion is recommended:

<u>Motion</u>: that Senate approve, and recommend to the Board of Governors that it also approve the proposal to discontinue the Latin American Literary and Cultural Studies program, as described in the document "Discontinuation of Latin American Literary and Cultural Studies".

The discontinuance of Latin American Literary and Cultural Studies (minor, major and honours)

Latin American Studies is currently divided into two programs. One is "Latin American Interdisciplinary Studies" and the other is "Latin American Literary and Cultural Studies (LALCS)". Over the years, the former has attracted far more students than the latter. LALCS replicates what is already offered by SPAN and is replicated in the "Latin American Interdisciplinary Studies" program. It is thus redundant and competes with SPAN. The proposed change would create one single Latin American Interdisciplinary Studies program that is distinct from SPAN and includes all the courses that are currently offered in the Latin American Interdisciplinary Studies program.

The goal is to better distinguish LAS from SPAN and simplify the LAS program for students, as it will now be one program instead of two. The proposed change has been developed in consultation with and with the support of the Latin American Studies programme committee and the chair of Hispanic and Italian Studies.

There are currently 4 students majoring in the Latin American Literary and Cultural Studies. All the courses the students need to complete their major will continue to be offered through the consolidated Latin American Studies major.

There are currently 4 students in the Latin American Literary and Cultural Studies (LALCS) program. These students will continue to have access to all the courses they need to complete their program, as these courses will be offered as part of the consolidated Latin American Interdisciplinary Studies programme (which we are also proposing to rename to "Latin American Studies" in a companion submission).

The proposed discontinuation will leave only one program offered by the Latin American Studies programme. This will avoid confusion and simplify students' choice and simplify the programme for students so that students will be more attracted to it.


