The 2017-18 Report covers the activities of the Committee in the period from its meeting October 11, 2017, through its meeting on April 4, 2018. During this period, the Committee held six meetings.

ACTION ITEMS APPROVED BY SENATE:

1. That the Senate Committee on Planning recommends that Senate approve, and recommend to the Board of Governors that it also approve, the request for the Discontinuation of the Registered Nurse to Master of Nursing option, as described in the document "Discontinuation of the RN to MN Option".

[Approved by Senate at its meeting on May 5, 2017]

2. That the Senate Committee on Planning recommends that Senate approve the Approved Centre Status for the Centre for Youth and Society (CFYS) for the period of 1 July 2017 through 30 June 2022. This recommendation is not contingent upon the suggestions in the external review report relating to resources, which are advice to the Vice-President Research.

3. That the Senate Committee on Planning recommends that Senate approve renaming of the Centre for Addictions Research BC (CARBC) as the Canadian Institute for Substance Use Research (CISUR), with the approval of CISUR as a multi-faculty research centre in effect until December 31, 2021.

6. That the Senate Committee on Planning recommends that Senate approve the name of the Nursing program offered in partnership with Camosun College be changed from "Joint Degree Program in Nursing" to the "(UVic) BSN in partnership with Camosun College".

7. That the Senate Committee on Planning recommends that Senate approve, and recommend to the Board of Governors that it also approve, subject to funding, the establishment of a major in Indigenous Studies, as described in the document "Indigenous Studies Major: Bachelor of Arts", and that this approval be withdrawn if the program should not be offered within five years of the granting of the approval.

8. That the Senate Committee on Planning recommends that Senate approve the major modification to the Student-designed Interdisciplinary Minor as proposed in the memorandum "Major curriculum changes to Student-designed Interdisciplinary Minor" dated December 7, 2017.

That the Senate Committee on Planning recommends that Senate approve the major modification to the Concentration in Cultural, Social and Political Thought (CSPT) program, as proposed in the memorandum originally submitted as "Minor curriculum change to the Concentration in Cultural, Social and Political Thought (CSPT) program" dated December 7, 2017.

10. That the Senate Committee on Planning recommends that Senate approve, and recommend to the Board of Governors that it also approve, the renewal of Approved Centre Status for the Pacific Institute for Climate Solutions (PICS) for the period April 1, 2018 through March 31, 2023.

11. That the Senate Committee on Planning recommends that Senate approve, and recommend to the Board of Governors that it also approve, subject to funding, the establishment of a Master of Management, as described in the document "Master of Management Degree", and that this approval be withdrawn if the program should not be offered within five years of the granting of approval. Once Senate and the Board of Governors have approved the proposal, the proposal must be approved by the Secretariat of the Ministry of Advanced Education, Skills and Training.

That the Senate Committee on Planning recommends that Senate approve, and recommend to the Board of Governors that it also approve, subject to funding, the establishment of a Research Project Option in the Master of Nursing and Master of Science in Health Informatics: Double Degree Program, as described in the document "Proposal to Offer Research Project Option in Master of Nursing and Master of Science in Health Informatics: Double Degree Program, as described in the document "Proposal to Offer Research Project Option in Master of Nursing and Master of Science in Health Informatics: Double Degree Program", and that this approval be withdrawn if the new option should not be offered within five years of the granting of approval.

13. That the Senate Committee on Planning recommends that Senate approve, and recommend to the Board of Governors that it also approve, subject to funding, the establishment of a Master of Engineering in Applied Data Science, as described in the document "Master of Engineering in Applied Data Science", and that this approval be withdrawn if the program should not be offered within five years of the granting of approval. Once Senate and the Board of Governors have approved the proposal, the proposal must be approved by the Secretariat of the Ministry of Advanced Education, Skills and Training.

14. That the Senate Committee on Planning recommends that Senate approve, and recommend to the Board of Governors that it also approve, the change of the name of the "Certificate in Aboriginal Language Revitalization (CALR)" to the "Certificate in Indigenous Language Revitalization (CILR)".
