# Consultations move into second phase for policy AC1205 renewal

The renewal of UVic's Policy on Academic Accommodation and Access for Students with Disabilities (AC1205) is moving into its second round of consultation.

# Provide feedback on the revised draft

"We've had some really productive conversations and feedback from students, staff, faculty and university leaders," says Kim Hart, an external consultant hired on behalf of the provost to support the policy renewal. "We seriously considered everything that we heard and have made a lot of changes to the policy in response. It's really important that we get this right, so we want one last check in with stakeholders."

A new discussion draft has been created, complete with comments indicating where major changes have occurred. The team also developed a separate guide to the changes in this latest draft. "We know that there is a lot to take in and we want to make this as easy as possible for people to understand and provide their feedback," adds Hart.

# What's changed with this version?

Please note: Some of the feedback received was related to operational matters – for example, that different classroom venues (labs, large lecture rooms, small classrooms) can each create different types of barriers to learning which should be taken into account in the accommodation plan. The project team will direct this type of input to the university's administration for consideration.

# Definitions

## Academic Accommodation

- What we heard Concern that the short list of academic accommodations within this definition replaces long list of examples in *current procedures*
- **Response** The long list of examples in *current procedures* has been retained but now appears in Schedule 1 to the Undergraduate Procedures

# Accessible

• **Changed text** – Added "Many barriers in the environment – physical, architectural, technological, attitudinal... hinder a person's full and equal participation in society."

# Disability

- What we heard Prefer the social model of disability
- Response Revised definition to refer to social model as it appears in the current Policy AC1205
- Changed text "means a ... hinders the person's full participation in the university's academic activities on an equal basis with others. The social model of disability locates impairment not within the individual but within the physical, social, and attitudinal barriers that exist in society."

# Essential Requirement

• **Changed text** – "The Essential Requirements are established by applying the factors set out in the procedures."

## Instructor

- What we heard Clarify whether this includes teaching assistants, lab instructors
- **Response** Definition revised to draw a distinction between the person who holds responsibility for the course and others who may be involved in either supporting or teaching it

• Changed text – "...the person who holds responsibility for a course (although there may be others such as a teaching assistant or a lab instructor who are engaged with course instruction) ...Graduate Supervisor (or Co-Supervisor)."

#### Non-credit learners

- What we heard Non-credit students are not mentioned in the Jan 19 Policy Discussion Draft
- **Response** Definition of Non-credit learners added; accommodation processes for these learners is *normally* through Division of Continuing Studies or through the unit offering the noncredit course. However, there may be situations where a student is registered in a mix of credit and non-credit courses, therefore requiring collaboration between CAL and other units.

#### Student

• **Comment** – Retained the Jan 19th version of "Student" - should not include 'prospective' or returning/re-admission students b/c they are not entitled to 'academic accommodation' per se but to accommodation within those processes as needed (e.g. alternative format application form).

## Undue hardship

- What we heard Prefer this legal concept be stated in the positive
- Comment Rewritten in response to community input about the phrase "is limited to providing". This is a different way of saying the same thing, but in the positive (duty to provide up to the point of undue hardship) vs. negative (limited to providing...without incurring undue hardship) and is probably easier for the community to understand. The clarifying point (undue hardship to whom?) has been retained (...to the university...). See also connection to Principles s.1.3 which refers to the university's legal obligations
- **Changed text** "The University of Victoria has a duty to provide... to the point of undue hardship...What constitutes undue hardship to the university..."

#### **Principles**

- What we heard Prefer to retain welcoming language in current Policy AC1205 at section 2.1
- Response Language from current Policy AC1205 inserted in sections 1.1-1.4
- Changed text
  - 1.1: Added "The University celebrates diversity within its community and welcomes the
    contributions, experiences, and full participation of persons with disabilities as valued
    members of the university community."
  - 1.2: "welcoming learning environment"

## Section 1.3

- **Changed text** "The University will provide reasonable academic...consistent with its educational mandate, academic principles, and legal obligations"
- **Comment**: As pointed out at Senate, the Jan 19 Discussion Draft affirmed UVic's duty but did not explicitly state "The University will provide..."

# Section 1.4

- Changed text "Developing and implementing...It requires participation, co-operation, and ...Disability and, where applicable, a Field Education or Practicum Coordinator, the Learning and Teaching Support and Innovation centre, and others. A collaborative working relationship between the people involved in each accommodation process ..."
- **Comment** "Developing and implementing" wording was in section 5.1 of the Jan 19 Discussion Draft. Included here in response to community input.

• **Comment** – This policy applies to Students with Disabilities who are seeking Academic Accommodation. This policy also applies to all university employees who share responsibility to accommodate Students with Disabilities.

#### Section 3.2

- What we heard Include non-credit learners
- Response As above, non-credit learners are supported through DCS, not through the CAL processes under AC1205
- Changed text "This policy does not apply to Non-Credit learners. Accommodation for Non-Credit learners is normally provided through the Division of Continuing Studies or through the Unit offering the non-credit course."
- Comment Added, to be explicit about who the policy does not apply to, and why

#### Section 3.3

- What we heard Policy should apply to Co-op work term placements or explain why it does not. Where do co-op students go for information, advice, and support for accommodation during a co-op work term?
- Response Policy does not apply to co-op work term placements. Clarified responsibility for accommodation in the workplace and added that co-op students should seek information, advice, and support from Co-operative Education Program and Career Services (see section 3.3.1). Also clarified workplace accommodation if student is employed by UVic (see section 3.3.2)
- Changed text "This policy does not apply to a Student's employment... to a Student's employment with the university because the duty to accommodate an employee in the workplace arises from the employer-employee relationship, and what constitutes reasonable workplace accommodation must be assessed within the context of the duties and responsibilities of the position.
  - 3.3.1 A Student who requires workplace accommodation for a Co-Op Work Term placement should seek information, advice, and support from Co-operative Education Program and Career Services.
  - 3.3.2 A Student employed by the university who requires workplace accommodation should seek information, advice, and support from their supervisor. Accommodation in employment is managed in accordance with applicable collective agreements, university policies and the university's regular employment practices."

# Section 4 – The University's Responsibilities

- What we heard Policy is silent about support(s) the University will provide to make courses more accessible, to determine essential requirements, and/or to implement academic accommodation
- **Response** Enhanced list of University Responsibilities includes support through LTSI (s.4.1.4.A); also see section 8.0 and linkages in section 6.1.a and 6.2
- **Comment** In the Jan 19 Discussion Draft, a portion of this list was in section 4.1 and the parts of it were under section 9.1. The lists have been combined here and section "h" added in response to community input about assistance for students whose Academic Accommodation plan is not being implemented in a timely way.
- Changed text
  - "4.1 The university has a responsibility to:
    - 4.1.1 Take steps towards making its programs and courses more accessible to qualified Students with Disabilities by mitigating barriers;
    - 4.1.2 Offer information, advice, guidance, and support to Students with Disabilities about the Academic Accommodation process;
    - 4.1.3 Provide reasonable Academic Accommodation to Students with Disabilities to the point of undue hardship, in a manner that is consistent with...
    - 4.1.4 ...
      - A. Through Learning and Teaching Support and Innovation ("LTSI")
        - (a) provide information and learning opportunities for Instructors to further inclusion and accessibility through the development of course learning

- outcomes and Essential Requirements, as well as through course design, instructional strategies, and course assessment.
- (b) provide guidance and evaluation for Instructors on the selection and use of learning technologies to ensure standards of accessibility; and
- (c) offer guidance and support for Instructors in implementing Academic Accommodations
- B. Through the Centre for Accessible Learning
  - (a) offer information, advice, guidance, and...

# Section 5 – Responsibilities of Students

- What we heard Policy lacks guidance for students whose Academic Accommodation Plan is not being implemented in a timely way
- **Response** Students are responsible for notifying CAL if accommodations are not implemented (s.5.3.f); Administrative Head's responsibilities include supporting the Student and the Instructor to implement the accommodations (s.7.1.c). Also see procedures.
- Changed text
  - "(f) notifying CAL in the event their Academic Accommodation plan is not being implemented in a timely way;
  - (g) upon admission to a professional or other program that includes field education or practicum placements, notifying the Field Education or Practicum Coordinator that accommodation may be required."
- **Comment** point (g) replaces section 6.4 in the Jan 19 Discussion Draft. The details of the field education/practicum accommodation process have been moved to procedures.

# Section 6 – Responsibilities of Instructors

- What we heard Policy lacks guidance for students whose Academic Accommodation Plan is not being implemented in a timely way
- **Response** Instructors must notify CAL if they have concern about Academic Accommodation plan or its implementation
- Changed text
  - 6.1. (a)"... Administrative Head) and with support from the LTSI and/or CAL, applying the factors set out in the procedures.
  - (c) ... and the Student, and with guidance from the LTSI as needed, to implement the Academic Accommodation plan;
  - (d) notify CAL immediately if the Academic Accommodation plan cannot be implemented.
  - 6.2 Instructors are expected and encouraged to create inclusive, supportive, and accessible learning environments through course design, instructional strategies, and course assessment and are encouraged to seek advice, guidance, and support from LTSI and from CAL."

# Section 8 – Responsibilities of the Learning Teaching Support and Innovation

- Changed Text Includes section name and "8.1. The Learning and Teaching Support and Innovation ("LTSI") is responsible for fulfilling its mandate, as set out in section 4.1.4.A (above), to provide information, learning opportunities, guidance, and support to Instructors."
- **Comment** New section, corresponds with new section 4.1.4.A (above) and responds to community input about support for Instructors

# Section 9.1 – CAL responsibilities

- Changed text "The Centre for Accessible Learning is responsible for fulfilling its mandate, as set out in section 4.1.4.B (above), to provide information, advice, guidance, and support to Students seeking Academic Accommodation and to those implementing the Academic Accommodation plan."
- **Comment** New wording to replace section 10.1 in the Jan 19 Discussion Draft; details moved to procedures

Process for Resolving Disagreements about Academic Accommodations

#### Section 11.1 - Instructor

- Changed text "An Instructor who for any reason disagrees with the Academic Accommodation plan must contact CAL promptly and follow the process for resolving disagreements as set out in the procedures."
- Comment process details moved to procedures

# Sections 11.2 and 11.3 - Student

- Changed text:
  - "11.2 A Student whose Academic Accommodation plan is not being implemented in a timely way in a course or a lab should contact their CAL Advisor as soon as possible.
  - 11.3 A Student who disagrees with their Academic Accommodation plan should bring their concerns to the attention of the Director of CAL (or designate) promptly and follow the process for resolving disagreements as set out in the procedures."
- Comment 11.2 added in response to community input that Students are uncertain what to do
  if their Academic Accommodation plan isn't being implemented. Moved process details to
  procedures 11.3 process details moved to procedures.

"Participate fully..." in point 35.b. adapted from Section 25 of current Graduate Students. "...that is appropriate..." in point 35.b.ii. phrasing is from Section 26 from current Undergraduate procedures. "If a Student" in point 36 is from Section 25.01 from current Graduate Student procedures. Added for consistency.

### Resolving Disagreements

- Comments "...has a duty to implement..." in point 37 replaces Section 27 from the current Undergraduate procedures, which states that an instructor may only deny an academic accommodation where the instructor believes it will constitute undue hardship. This states the duty in the positive, rather than the negative. "An instructor who disagrees..." in point 38 aligns with Section 6.1.d and 11.1 from discussion draft policy. "A Student..." in point 29 aligns with Section 11.2 and 11.3 in policy discussion draft 2. "...Senate Committee on Appeals..." in point 41 are from Section 35 and 35.01 in the current Undergraduate procedures.
